THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SUBPART 3

PERCHLOROETHYLENE

Sec. 14731. (1) Beginning December 1, 2027, a person shall not manufacture a dry cleaning solvent that contains perchloroethylene.

- 1 (2) Beginning June 1, 2028, a person shall not sell a dry 2 cleaning solvent that contains perchloroethylene.
- 3 (3) Beginning December 1, 2028, a person shall not use as a dry cleaning solvent a product that contains perchloroethylene.
- 5 Sec. 14733. (1) The perchloroethylene fund is created within
- 6 the state treasury. The state treasurer may receive money or other
- 7 assets from any source for deposit into the fund. The state
- 8 treasurer shall direct the investment of the fund and credit to the
- 9 fund interest and earnings from fund investments. Money in the fund
- 10 at the close of the fiscal year remains in the fund and does not
- 11 lapse to the general fund.
- 12 (2) Upon appropriation, the department shall expend money from
- 13 the fund to do all of the following:
- 14 (a) Provide grants under the cost-share program provided for

- 22 promulgate rules to implement a cost-share program to provide
- 23 grants to dry cleaning facilities to cover the costs of
- 24 transitioning from products that contain perchloroethylene to
- 25 alternative products, and establish all of the following:
- 26 (a) Eligibility and selection criteria.
- 27 (b) Application requirements.
- (c) Eligible alternative products and dry cleaning processes.
- 29 (d) A buy-back program to ensure safe disposal of existing

- 1 products that contain perchloroethylene from dry cleaning

- 3 (4) The department shall make the information on the cost-
- 4 share program available on its website.
- 5 (5) As used in this section, "fund" means the
- 6 perchloroethylene fund created in subsection (1).
- 7 Sec. 14735. A person that violates section 14731 may be
- 8 ordered to pay a civil fine of not more than \$10,000.00. A
- 9 violation of section 14731 may be prosecuted by the prosecutor of
- 10 the county in which the violation occurred or by the attorney
- 11 general.
