- 1 Sec. 1a. As used in this act:
 - (a) "Department" means the department of state police.

- 1 (c) "OK2SAY program" means this state's student safety program
- 2 that allows students to confidentially report tips on potential

- 7 or any grade from 1 through 12, regardless of whether school is in

- 10 of a school, school district, or intermediate school district,
