THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 29 (d) If the violation causes serious impairment of a body

- 1 function to another individual, the person is guilty of a felony
- 2 punishable by imprisonment for life or any term of years or a fine
- 3 of not more than \$25,000.00, or both. As used in this subdivision,
- 4 "serious impairment of a body function" means that term as defined
- 5 in section 58c of the Michigan vehicle code, 1949 PA 300, MCL

- 7 (e) Except as provided in sections 25 and 25a of chapter IX of
- 8 the code of criminal procedure, 1927 PA 175, MCL 769.25 and
- 9 $\frac{769.25a}{}$ for a person who was less than 19 years of age at the time
- 10 of the violation, if the violation causes the death of another
- 11 individual, the person is guilty of a felony and shall be
- 12 imprisoned for life without eligibility for parole and may be fined
- 13 not more than \$40,000.00. , or both. If the violation was committed
- 14 by a person who was less than 19 years of age at the time of the
- 15 violation and causes the death of another individual, the person is
- 16 guilty of a felony and shall be punished by imprisonment with a
- 17 minimum term of not less than 10 years and maximum term of not more
- 18 than 60 years and may be fined not more than \$40,000.00.
- 19 (3) A person who violates subsection (1)(b) is guilty of a
- 20 crime as follows:
- 21 (a) Except as provided in subdivision (b), the person is
- 22 guilty of a felony punishable by imprisonment for not more than 4
- 23 years or a fine of not more than \$2,000.00, or both.
- 24 (b) If the person has previously been convicted of violating
- 25 subsection (1)(b), the person is guilty of a felony punishable by
- 26 imprisonment for not more than 10 years or a fine of not more than

- (4) The court may order a term of imprisonment imposed for a

 the same transaction as the violation of this section.
- 3 (5) This section does not prohibit an individual from being4 charged with, convicted of, or punished for any other violation of
- 5 law that is committed by that individual while violating this

- 7 Sec. 506b. Notwithstanding any provision to the contrary in
- 8 this act, an individual who was less than 19 years of age at the
- 9 time the individual committed a crime must not be sentenced to
- 10 imprisonment for life without parole eligibility for that crime.
- 11 Sec. 543f. (1) A person is guilty of terrorism when that
- 12 person knowingly and with premeditation commits an act of
- 13 terrorism.
- 14 (2) Terrorism is a felony punishable by imprisonment for life
- or any term of years or a fine of not more than \$100,000.00, or
- 16 both. However, except as provided in sections 25 and 25a of chapter
- 17 IX of the code of criminal procedure, 1927 PA 175, MCL 769.25 and
- $\frac{769.25a}{}$ for a person who was less than 19 years of age at the time
- 19 of the violation, if death was caused by the terrorist act, the
- 20 person shall be punished by imprisonment for life without

- 25 not less than 10 years and maximum term of not more than 60 years.
