THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 2980. (1) A person that engages in false representation in assisted reproduction is liable to an individual described in subsection (2) for 1 or more of the following:
- 4 (a) Economic and noneconomic damages.
- 5 (b) Punitive damages.

- 1 (c) Reasonable attorney fees and costs.
- 2 (2) Any individual who is injured by a false representation in
- 3 assisted reproduction may bring an action under this section,
- 4 including, but not limited to, any of the following:
- 5 (a) The patient who gives birth to a child conceived through

- 7 assisted reproduction.
- 8 (b) The patient's spouse at the time the patient used the
