A bill to amend 1972 PA 222, entitled

"An act to provide for an official personal identification card; to provide for its form, issuance and use; to regulate the use and disclosure of information obtained from the card; to prescribe the powers and duties of the secretary of state; to prescribe fees; to prescribe certain penalties for violations; and to provide an appropriation for certain purposes,"

by amending section 1 (MCL 28.291), as amended by 2021 PA 105.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. (1) An individual who is a resident of this state may

- 1 apply to the secretary of state for an official state personal
- 2 identification card. Upon Except as otherwise provided in
- 3 subsection (4), upon application, the applicant shall supply a
- 4 photographic identity document, a birth certificate or other
- 5 nonphotographic identity document, and other sufficient documents
- 6 as the secretary of state may require to verify the identity and
- 7 citizenship of the applicant. If an applicant for an official state
- 8 personal identification card is not a citizen of the United States,
- 9 the applicant shall supply a photographic identity document and
- 10 other sufficient documents to verify the identity of the applicant
- 11 and the applicant's legal presence in the United States under
- 12 subsection (5). (6). The documents required under this subsection
- 13 must include the applicant's full legal name, date of birth,
- 14 address, and residency and demonstrate that the applicant is a
- 15 citizen of the United States or is legally present in the United
- 16 States. If the applicant's full legal name differs from the name of
- 17 the applicant that appears on a document presented under this
- 18 subsection, the applicant shall present documents to verify his or
- 19 her the applicant's current full legal name. An application for an
- 20 official state personal identification card must be made in a
- 21 manner prescribed by the secretary of state and must contain the
- 22 applicant's full legal name, date of birth, residence address,
- 23 height, sex, gender, eye color, signature, intent to be an organ
- 24 donor, other information required or permitted on the official
- 25 state personal identification card and, only to the extent to
- 26 comply with federal law, the applicant's Social Security number.
- 27 The applicant may provide a mailing address if the applicant
- 28 receives mail at an address different from his or her the
- 29 applicant's residence address. Beginning June 27, 2021, if the

- 1 applicant is a program participant in the address confidentiality
- 2 program under the address confidentiality program act, 2020 PA 301,
- 3 MCL 780.851 to 780.873, he or she the applicant shall present to
- 4 the secretary of state his or her the applicant's participation
- 5 card issued under the address confidentiality program act, 2020 PA
- 6 301, MCL 780.851 to 780.873. For automatic voter registration
- 7 purposes under section 493a of the Michigan election law, 1954 PA
- 8 116, MCL 168.493a, an applicant for an official state personal
- 9 identification card must indicate on the application or change of
- 10 address application whether he or she the applicant is a citizen of
- 11 the United States. An application must allow the applicant to
- 12 indicate that the applicant declines to use the application as a
- 13 voter registration application.
- 14 (2) The secretary of state shall accept as 1 of the
- 15 identification documents required under subsection (1) an
- 16 identification card issued by the department of corrections to
- 17 prisoners who are placed on parole or released from a correctional
- 18 facility, containing the prisoner's legal name, photograph, and
- 19 other information identifying the prisoner as provided in section
- 20 37(4) of the corrections code of 1953, 1953 PA 232, MCL 791.237.
- 21 (3) The secretary of state shall have electronic access to
- 22 prisoner information maintained by the department of corrections
- 23 for the purpose of verifying the identity of a prisoner who applies
- 24 for an official state identification card under subsection (1).
- 25 (4) Beginning October 1, 2023, on receipt of application
- 26 documents required under subsection (1), a prisoner's photograph,
- 27 and information on the projected date a prisoner will be released
- 28 on parole or discharged upon completion of the prisoner's maximum
- 29 sentence from the department of corrections as provided under

- 1 section 34c of the corrections code of 1953, 1953 PA 232, MCL
- 2 791.234c, the secretary of state shall, to the extent possible,
- 3 issue an official state personal identification card to the
- 4 prisoner, if the prisoner is eligible to be issued an official
- 5 state personal identification card under this act. The secretary of
- 6 state shall do any of the following:
- 7 (a) Deliver the official state personal identification card
- 8 issued pursuant to this section to the department of corrections
- 9 before the projected date the prisoner issued the official state
- 10 personal identification card is scheduled to be released on parole
- 11 or discharged upon completion of the prisoner's maximum sentence.
- 12 (b) Mail the official state personal identification card
- 13 issued pursuant to this section as soon as possible to the
- 14 department of corrections. This subdivision applies if both of the
- 15 following conditions are met:
- 16 (i) The secretary could not comply with subdivision (a).
- 17 (ii) The prisoner is already released on parole or discharged
- 18 upon the completion of the prisoner's maximum sentence.
- 19 (5) (4) The secretary of state shall not issue an official
- 20 state personal identification card to an individual who holds an
- 21 operator's or chauffeur's license issued under the Michigan vehicle
- 22 code, 1949 PA 300, MCL 257.1 to 257.923, unless the license has
- 23 been suspended, revoked, or restricted.
- **24 (6)** (5) If the applicant is not a citizen of the United
- 25 States, the applicant shall provide, and the department shall
- 26 verify, documents demonstrating his or her the applicant's legal
- 27 presence in the United States. Nothing in this act obligates this
- 28 state to comply with title II of the real ID act of 2005, Public
- 29 Law 109-13. The secretary of state may adopt rules under the

- 1 administrative procedures act of 1969, 1969 PA 306, MCL 24.201 to
- 2 24.328, as are necessary for the administration of this subsection.
- 3 A determination by the secretary of state that an applicant is not
- 4 legally present in the United States may be appealed under section
- 5 631 of the revised judicature act of 1961, 1961 PA 236, MCL
- 6 600.631. The secretary of state shall not issue an official state
- 7 personal identification card to an applicant described in this
- 8 subsection for a term that exceeds the duration of the applicant's
- 9 legal presence in the United States.
- 10 (7) (6) The secretary of state shall not disclose a Social
- 11 Security number obtained under subsection (1) to another person
- 12 except for use for 1 or more of the following purposes:
- 13 (a) Compliance with 49 USC 31301 to 31317 and regulations and
- 14 rules related to this act.
- 15 (b) To carry out the purposes of section 466(a) of the social
- 16 security act, 42 USC 666, in connection with matters relating to
- 17 paternity, child support, or overdue child support.
- 18 (c) To the department of health and human services, for
- 19 comparison with vital records maintained by the department of
- 20 health and human services under part 28 of the public health code,
- 21 1978 PA 368, MCL 333.2801 to 333.2899.
- 22 (d) As otherwise required by law.
- 23 (8) $\frac{(7)}{}$ The secretary of state shall not display an
- 24 individual's Social Security number on the individual's official
- 25 state personal identification card.
- 26 (9) (8)—A requirement under this section to include a Social
- 27 Security number on an application does not apply to an applicant
- 28 who demonstrates that he or she the applicant is exempt under law
- 29 from obtaining a Social Security number.

- 1 (10) (9) The secretary of state, with the approval of the state administrative board created under 1921 PA 2, MCL 17.1 to
- 3 17.3, may enter into agreements with the United States government
- 4 to verify whether an applicant for an official state personal
- 5 identification card under this section who is not a citizen of the
- 6 United States is authorized under federal law to be present in the
- 7 United States.
- 8 (11) (10) The secretary of state shall not issue an official
- 9 state personal identification card to an individual holding an
- 10 official state personal identification card issued by another state
- 11 without confirmation that the individual is terminating or has
- 12 terminated the official state personal identification card issued
- 13 by the other state.
- 14 (12) (11) The secretary of state shall do all of the
- 15 following:
- 16 (a) Ensure the physical security of locations where official
- 17 state personal identification cards are produced and the security
- 18 of document materials and papers from which official state personal
- 19 identification cards are produced.
- 20 (b) Subject each person authorized to manufacture or produce
- 21 official state personal identification cards and each person who
- 22 has the ability to affect the identity information that appears on
- 23 official state personal identification cards to appropriate
- 24 security clearance requirements. The security requirements of this
- 25 subdivision and subdivision (a) may require that official state
- 26 personal identification cards be manufactured or produced in this
- 27 state.
- 28 (c) Provide fraudulent document recognition programs to
- 29 secretary of state employees engaged in the issuance of official

- 1 state personal identification cards.
- 2 (13) (12)—If an individual meets the requirements under
- 3 subsection (13), (14), beginning July 1, 2021, the secretary of
- 4 state shall allow the individual to elect a communication
- 5 impediment designation on the application maintained in the central
- 6 file under section 7 or in another appropriate system that limits
- 7 access to a person allowed access to public record information by
- 8 the criminal justice information policy council under the C.J.I.S.
- 9 policy council act, 1974 PA 163, MCL 28.211 to 28.215, and that
- 10 allows a person with access to view a communication impediment
- 11 designation with an official state personal identification card.
- 12 (14) (13) An individual seeking an election for a
- 13 communication impediment designation under subsection (12) (13)
- 14 shall provide the secretary of state a certification that meets all
- 15 of the following:
- 16 (a) Is signed by a physician, physician assistant, certified
- 17 nurse practitioner, audiologist, speech-language pathologist,
- 18 psychologist, or physical therapist licensed to practice in this
- 19 state.
- 20 (b) Identifies the individual for whom the communication
- 21 impediment designation is being elected.
- (c) Attests to the nature of the health condition that may
- 23 impede communication.
- 24 (15) (14) The secretary of state shall not display an
- 25 individual's communication impediment designation on the
- 26 individual's official state personal identification card.
- 27 (16) (15) A person who intentionally makes a false statement
- 28 of material fact or commits or attempts to commit a deception or
- 29 fraud on a statement described under subsection (13) (14) is guilty

- of a misdemeanor punishable by imprisonment for not more than 30 days or a fine of not more than \$500.00, or both.
- 3 (17) (16)—Subject to subsection (17), (18), the secretary of 4 state may cancel or revoke a communication impediment designation 5 elected and maintained under this section if either of the 6 following circumstances applies:
- 7 (a) The secretary of state determines that a communication8 impediment designation was fraudulently or erroneously elected.
- 9 (b) The secretary of state determines the communication10 impediment designation was abused during a traffic stop.
 - (18) $\frac{(17)}{(17)}$ The secretary of state shall provide an individual notice and an opportunity to be heard before canceling or revoking a communication impediment designation under subsection $\frac{(16)}{(17)}$.
- 14 (19) (18) As used in this section, "communication impediment"
 15 means an individual has a health condition that may impede
 16 communication with a police officer, including, but not limited to,
 17 any of the following:
- 18 (a) Deafness or hearing loss.

- 19 (b) An autism spectrum disorder.
- Enacting section 1. This amendatory act does not take effect unless all of the following bills of the 102nd Legislature are enacted into law:
