## **HOUSE BILL NO. 4667**

May 25, 2023, Introduced by Reps. Hill, McKinney, Snyder, O'Neal, Liberati, McFall, Price, Tyrone Carter and Paiz and referred to the Committee on Labor.

A bill to amend 1986 PA 182, entitled
"State police retirement act of 1986,"
