## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1060. (1) When delivering a document described in this

- (t) Certificate of termination of registration of corporate
   name of a foreign corporation, \$10.00.
- 3 (u) Report required under section 911, \$15.00 if paid after
  4 September 30, 2023. Before October 1, 2023, the fee is \$25.00.
- 5 (2) The fees described in subsection (1) are in addition to
  6 any franchise fees prescribed in this act. The administrator shall
  7 not refund all or any part of a fee described in this section.
- 8 (3) Except as provided in subsection (9), the administrator
  9 shall deposit all fees received and collected under this section in
  10 the state treasury to the credit of the administrator, who may only
  11 use the money credited pursuant to in accordance with legislative
  12 appropriation and only in carrying out those duties of the
  13 department required by law.
- 14 (4) The fees described in this section apply to documents
  15 filed by a domestic or foreign regulated investment company as that
  16 term is defined in section 1064.

- (5) If any money received by the administrator from fees paid under subsection (1)(u) is not appropriated to the department in that fiscal year, the money remaining from those fees shall revert reverts to the general fund of this state.
- (6) A minimum charge of \$1.00 for each certificate and 50 cents per folio shall must be paid to the administrator for certifying a part of a file or record pertaining to a corporation if a fee for that service is not described in subsection (1). The administrator may furnish copies of documents, reports, and papers required or permitted by law to be filed with the administrator, and shall charge for those copies the fee established in a schedule of fees adopted by the administrator with the approval of the state administrative board. The administrator shall retain the revenue

- collected under this subsection, and the department shall use it todefray the costs for its copying and certifying services.
- 3 (7) If a domestic or foreign corporation pays fees or
  4 penalties by check and the check is dishonored, or by credit card
  5 and a chargeback is successful, the fee is unpaid and the
  6 administrator shall rescind the filing of all related documents.

- (8) The administrator may accept a credit card in lieu of cash or check as payment of a fee under this act. The administrator shall determine which credit cards he or she shall accept the administrator accepts for payment.
- (9) The administrator may charge a nonrefundable fee of up to not more than \$50.00 for any document submitted or certificate sent by facsimile or electronic transmission. The administrator shall retain the revenue collected under this subsection and the department shall use it to carry out its duties required by law.
- 16 (10) The administrator shall waive any fee otherwise required 17 under this section if a majority of the shares of the domestic or 18 foreign corporation responsible for paying the fee are, and the 19 corporation provides proof satisfactory to the administrator that 20 those shares are, held by 1 or more honorably discharged veterans 21 of the Armed Forces of the United States.
