THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 9130. (1) The department shall maintain a perinatal
- 2 quality collaborative to support and improve maternal and infant
- 3 health outcomes in this state by doing all of the following:
- 4 (a) Promoting quality improvement efforts.
- 5 (b) Identifying processes and mobilizing resources.
- 6 (c) Advancing equity.
- 7 (d) Implementing and expanding care for families affected by

- 1 perinatal substance use disorder.
- 2 (e) Expanding and improving access to quality and respectful
- 3 care and support throughout the pregnancy and postpartum period.
- 4 (2) The perinatal quality collaborative shall establish
- 5 regional perinatal quality collaboratives for prosperity regions in
- 6 this state. Each regional perinatal quality collaborative shall
- 7 designate a lead agency within its region to invite qualified
- 8 persons within the region to participate in the regional perinatal
- 9 quality collaborative. Subject to appropriation, the department
- 10 shall provide resources to each regional perinatal quality
- 11 collaborative and require each regional perinatal quality
- 12 collaborative to do all of the following:
- 13 (a) Convene qualified persons and other interested persons
- 14 within the region for regular meetings to review qualitative and
