HOUSE BILL NO. 5342

November 14, 2023, Introduced by Reps. Shannon, BeGole, Mueller, Borton, Kuhn, Kunse, Martin, Roth, Bezotte, McKinney, Slagh, Wozniak, Beson, Schmaltz, Thompson, Zorn, Neyer, Markkanen, Alexander, Phil Green and Outman and referred to the Committee on Transportation, Mobility and Infrastructure.

A bill to amend 1949 PA 300, entitled "Michigan vehicle code,"

by amending section 312e (MCL 257.312e), as amended by 2022 PA 193.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 312e. (1) Except as otherwise provided in this section,an individual, before operating a commercial motor vehicle, shall
- 3 obtain the required vehicle group designation as follows:
- 4 (a) An individual, before operating a combination of motor
- 5 vehicles with a gross combination weight rating or gross
- 6 combination weight of 26,001 pounds or more, whichever is greater,
- 7 inclusive of towed units with a gross vehicle weight rating or

- 1 gross vehicle weight of more than 10,000 pounds, shall procure a
- 2 group A vehicle designation on his or her the individual's
- 3 operator's or chauffeur's license. Unless an endorsement or the
- 4 removal of restrictions is required, an individual licensed to
- 5 operate a group A vehicle may operate a group B or C vehicle
- 6 without taking another test.
- 7 (b) An individual, before operating a single vehicle having a
- 8 gross vehicle weight rating or gross vehicle weight of 26,001
- 9 pounds or more, whichever is greater, including while towing a
- 10 vehicle having a gross vehicle weight rating or gross vehicle
- 11 weight of not more than 10,000 pounds, shall procure a group B
- 12 vehicle designation on his or her the individual's operator's or
- 13 chauffeur's license. Unless an endorsement or the removal of
- 14 restrictions is required, an individual licensed to operate a group
- 15 B vehicle may operate a group C vehicle without taking another
- **16** test.
- 17 (c) An individual, before operating a single vehicle or a
- 18 combination of vehicles that fits the definition of small vehicle
- 19 (group C) under 49 CFR 383.91(a)(3), shall procure a group C
- 20 vehicle designation and a hazardous material or passenger vehicle
- 21 endorsement on his or her the individual's operator's or
- 22 chauffeur's license.
- 23 (2) An applicant for a vehicle group designation shall take
- 24 knowledge and driving skills tests that comply with minimum federal
- 25 standards prescribed in 49 CFR part 383 as required under this act
- 26 and, beginning February 7, 2022, complete the entry level driver
- 27 training described and required under 49 CFR part 380.
- 28 (3) The license must be issued, suspended, revoked, canceled,
- 29 or renewed in accordance with this act.

- 1 (4) Except as provided in this subsection, all of the2 following apply:
- (a) If an individual operates a group B passenger vehicle while taking his or her the individual's driving skills test for a P endorsement, he or she the individual is restricted to operating only group B or C passenger vehicles under that P endorsement. If an individual operates a group B school bus while taking his or her the individual's driving skills test for an S endorsement, he or she the individual is restricted to operating only group B or C school buses under that S endorsement. Except as provided in this section, beginning July 8, 2015, the secretary of state shall place on the commercial learner's permit or commercial driver license the following restriction code as provided under 49 CFR 383.95 and 383.153: not valid to operate a group A passenger commercial motor vehicle.

- (b) If an individual operates a group C passenger vehicle while taking his or her the individual's driving skills test for a P endorsement, he or she the individual is restricted to operating only group C passenger vehicles under that P endorsement. If an individual operates a group C school bus while taking his or her the individual's driving skills test for an S endorsement, he or she the individual is restricted to operating only group C school buses under that S endorsement. Except as provided in this section, beginning July 8, 2015, the secretary of state shall place on the commercial learner's permit or commercial driver license the following restriction code as provided under 49 CFR 383.95 and 383.153: not valid to operate a group A or group B passenger commercial motor vehicle.
 - (c) An individual who fails the air brake portion of the

- 1 written or driving skills test provided under section 312f or who
- 2 takes the driving skills test provided under that section in a
- 3 commercial motor vehicle that is not equipped with air brakes shall
- 4 not operate a commercial motor vehicle equipped with air brakes.
- 5 Except as provided in this section, beginning July 8, 2015, the
- 6 secretary of state shall place on the commercial learner's permit
- 7 or commercial driver license the following restriction code as
- 8 provided under 49 CFR 383.95 and 383.153: CDL not valid for vehicle
- 9 with air brakes.
- 10 (d) Except as provided in this section, beginning July 8,
- 11 2015, the secretary of state shall place on a commercial learner's
- 12 permit or commercial driver license the following restriction codes
- 13 as provided under 49 CFR 383.95 and 383.153:
- 14 (i) For a commercial learner's permit:
- 15 (A) No passengers in a commercial motor vehicle bus.
- 16 (B) No cargo in a commercial motor vehicle tank vehicle.
- 17 (C) Commercial motor vehicle operation with medical variance.
- 18 (D) Commercial motor vehicle operation intrastate only.
- 19 (ii) For a commercial driver license:
- 20 (A) Not valid to operate commercial motor vehicle equipped
- 21 with full air brakes.
- 22 (B) Not valid to operate commercial motor vehicle equipped
- 23 with manual transmission.
- 24 (C) Not valid to operate a group A commercial vehicle tractor-
- 25 trailer combination connected by fifth wheel.
- **26** (D) Commercial motor vehicle operation intrastate only.
- 27 (E) Commercial motor vehicle operation with medical variance.
- 28 (5) An individual, before operating a commercial motor
- 29 vehicle, shall obtain the following vehicle endorsements as

1 provided under 49 CFR 383.93 and 383.153:

- (a) An individual, before operating a commercial motor vehicle
 pulling double trailers, shall obtain the appropriate vehicle group
 designation and a T vehicle endorsement under this act.
- (b) An individual applying for a commercial learner's permit to operate an empty tank motor vehicle shall obtain the appropriate vehicle group designation and an N endorsement. An individual, before operating a tank motor vehicle, shall have on a commercial driver license the appropriate vehicle group designation and an N vehicle endorsement under this act.
- 11 (c) Until February 6, 2022, an individual, before operating a commercial motor vehicle carrying hazardous materials on which a 12 placard is required under 49 CFR parts 100 to 199, shall procure 13 14 the appropriate vehicle group designation and an H vehicle 15 endorsement under this act. Beginning February 7, 2022, an 16 individual, before operating a commercial motor vehicle carrying hazardous materials on which a placard is required under 49 CFR 17 18 parts 100 to 199, shall complete the entry level driver training 19 described and required under 49 CFR part 380 to procure the 20 appropriate vehicle group designation and an H vehicle endorsement 21 under this act.
 - (d) An individual, before operating a tank motor vehicle carrying hazardous materials, shall obtain the appropriate vehicle group designation and both an N and H vehicle endorsement, which must be designated by the code letter X on the individual's operator's or chauffeur's license.
- (e) An individual applying for a commercial learner's permit
 to operate a passenger commercial motor vehicle that is not a
 school bus, as set forth in section 306a(2)(e), shall obtain the

- 1 appropriate commercial vehicle group designation and a P
- 2 endorsement. An individual, before operating a vehicle that is
- 3 designed to transport 16 or more passengers including the driver
- 4 but that is not a school bus must have on a commercial driver
- 5 license the appropriate vehicle group designation and a P vehicle
- 6 endorsement under this act. An applicant for a P vehicle
- 7 endorsement must take the driving skills test in a vehicle designed
- 8 to transport 16 or more passengers including the driver and,
- 9 beginning February 7, 2022, complete the entry level driver
- 10 training described and required under 49 CFR part 380.
- 11 (f) An individual applying for a commercial learner's permit
- 12 to operate a school bus designed to transport 16 or more
- 13 passengers, including the driver, as set forth in section
- 14 306a(2)(e), who does not currently possess a P endorsement, shall
- 15 obtain the appropriate vehicle group designation and pass the
- 16 knowledge tests for both the P and S endorsements. An individual,
- 17 before operating a school bus, must have on a commercial driver
- 18 license the appropriate vehicle group designation and both the P
- 19 and S vehicle endorsements under this act. An applicant for an S
- 20 vehicle endorsement shall take a driving skills test in a school
- 21 bus designed to transport 16 or more passengers, including the
- 22 driver, that represents the same type of vehicle that the applicant
- 23 intends to operate as a school bus and, beginning February 7, 2022,
- 24 complete the entry level driver training described and required
- 25 under 49 CFR part 380.
- 26 (q) An individual who currently possesses a P endorsement and
- 27 is applying for a commercial learner's permit to operate a school
- 28 bus designed to transport 16 or more passengers, including the
- 29 driver, as set forth in section $\frac{306(a)(2)(e)}{}$, $\frac{306a(2)(e)}{}$, shall

- 1 obtain the appropriate vehicle group designation and pass the
- 2 knowledge test for the S endorsement. An individual who currently
- 3 possesses a P endorsement, before operating a school bus designed
- 4 to transport 16 or more passengers, including the driver, shall
- 5 obtain the appropriate vehicle group designation, pass the
- 6 knowledge test for an S endorsement, and obtain an S vehicle
- 7 endorsement for his or her the individual's commercial driver
- 8 license under this act. An applicant for an S vehicle endorsement
- 9 shall take a driving skills test in a school bus designed to
- 10 transport 16 or more passengers, including the driver, that
- 11 represents the same type of vehicle that the applicant intends to
- 12 operate as a school bus and, beginning February 7, 2022, complete
- 13 the entry level driver training described and required under 49 CFR
- **14** part 380.
- 15 (6) An applicant for an endorsement shall take the knowledge
- 16 and driving skills tests described and required under 49 CFR part
- 17 383 and, beginning February 7, 2022, complete the entry level
- 18 driver training described and required under 49 CFR part 380.
- 19 (7) The holder of an unexpired operator's or chauffeur's
- 20 license may be issued a vehicle group designation and endorsement
- 21 valid for the remainder of the license upon meeting the
- 22 qualifications of section 312f, and payment of the original vehicle
- 23 group designation fee of \$25.00, and an endorsement fee of \$5.00
- 24 per endorsement, and a corrected license fee of \$18.00. An
- 25 individual required to procure an F vehicle endorsement under
- 26 subsection (9) shall pay an endorsement fee of \$5.00.
- 27 (8) Except as otherwise provided in subsections (9) and (10),
- 28 this section does not apply to a driver or operator of a vehicle
- 29 under all of the following conditions:

- (a) The vehicle is controlled and operated by a farmer or an
 employee or family member of the farmer.
- 3 (b) The vehicle is used to transport agricultural products,
 4 farm machinery, farm supplies, or a combination of these those
 5 items, to or from a farm.
- 6 (c) The vehicle is not used in the operation of a common or7 contract motor carrier.
- 8 (d) The vehicle is operated within 150 miles of the farm.
- 9 (9) An individual, before driving or operating a combination 10 of vehicles having a gross vehicle weight rating of 26,001 pounds 11 or more on the power unit that is used as described in subsection 12 (8)(a) to (d), shall obtain an F vehicle endorsement. The F vehicle 13 endorsement must be issued upon successful completion of a 14 knowledge test only.
- 15 (10) An individual, before driving or operating a single 16 vehicle truck having a gross vehicle weight rating of 26,001 pounds 17 or more or a combination of vehicles having a gross vehicle weight 18 rating of 26,001 pounds or more on the power unit that is used as 19 described in subsection (8)(a) to (d) for carrying hazardous 20 materials on which a placard is required under 49 CFR parts 100 to 199, shall successfully complete both a knowledge test and a 21 driving skills test. Upon successful completion of the knowledge 22 23 test and driving skills test, the individual shall must be issued 24 the appropriate vehicle group designation and any vehicle 25 endorsement necessary under this act.
 - (11) This section does not apply to the following individuals:
- (a) a A police officer operating an authorized emergency
 vehicle. or to a

29 (b) A firefighter or Michigan Mutual Aid Box Alarm System

- 1 employee or member who is operating an authorized emergency vehicle
- 2 who—and has met the driver training standards published under the
- 3 firefighters training council act, 1966 PA 291, MCL 29.361 to
- 4 29.377.
- 5 (12) This section does not apply to an individual operating a
- 6 vehicle used exclusively to transport personal possessions or
- 7 family members for nonbusiness purposes.
- **8** (13) The money collected under subsection (7) for a vehicle
- 9 group designation or endorsement must be deposited in the state
- 10 treasury to the credit of the general fund. The secretary of state
- 11 shall refund out of the fees collected to each county or
- 12 municipality acting as an examining officer or examining bureau
- 13 \$3.00 for each applicant examined for a first designation or
- 14 endorsement to an operator's or chauffeur's license and \$1.50 for
- 15 each renewal designation or endorsement to an operator's or
- 16 chauffeur's license, whose application is not denied, on the
- 17 condition that the money refunded must be paid to the county or
- 18 local treasurer and is appropriated to the county, municipality, or
- 19 officer or bureau receiving that money for the purpose of carrying
- 20 out this act.
- 21 (14) Notwithstanding any other provision of this section, an
- 22 individual operating a vehicle described in subsections (8) and (9)
- 23 is subject to the provisions of sections 303 and 319b.
- 24 (15) This state shall comply with the requirements of the
- 25 American Association of Motor Vehicle Administrators' AAMVAnet,
- 26 Incorporated's "Commercial Driver License Information System
- 27 (CDLIS) State Procedures Manual" that the secretary of state
- 28 determines are required for implementing to implement and enforcing
- 29 enforce federal law.

- 1 Enacting section 1. This amendatory act does not take effect
