THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 2980. (1) A person is liable to the owner of a service animal for damages that result from an injury to the service animal, including, but not limited to, the death of the service animal, that is caused by the person or by an animal owned by the
