A bill to amend 1976 PA 388, entitled "Michigan campaign finance act,"

by amending sections 5 and 7 (MCL 169.205 and 169.207), section 5 as amended by 2019 PA 93 and section 7 as amended by 2001 PA 250.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 5. (1) "Domestic dependent sovereign" means an Indian
- 2 tribe that has been acknowledged, recognized, restored, or
- 3 reaffirmed as an Indian tribe by the secretary of the interior
- 4 pursuant to the Indian reorganization act, 25 USC 5101 to 5144,

- 1 commonly referred to as the Indian reorganization act, or has
- 2 otherwise been acknowledged by the United States government as an
- 3 Indian tribe.
- 4 (2) "Election" means a primary, general, special, or millage
- 5 election held in this state or a convention or caucus of a
- 6 political party held in this state to nominate a candidate.
- 7 Election includes a recall vote.
- **8** (3) "Election cycle" means 1 of the following:
- 9 (a) For a general election, the period beginning the day
- 10 following the last general election in which the office appeared on
- 11 the ballot and ending on the day of the general election in which
- 12 the office next appears on the ballot.
- 13 (b) For a special election, the period beginning the day a
- 14 special general election is called or the date the office becomes
- 15 vacant, whichever is earlier, and ending on the day of the special
- 16 general election.
- 17 (4) "Elected official" means an individual who holds a state
- 18 elective office.
- 19 (5) (4) "Elective office" means a public office filled by an
- 20 election. An individual who is appointed to fill a vacancy in a
- 21 public office that is ordinarily elective holds an elective office.
- 22 Elective office does not include the office of precinct delegate.
- 23 Except for the purposes of sections 47, 54, and 55, elective office
- 24 does not include a school board member in a school district that
- 25 has a pupil membership of 2,400 or less enrolled on the most recent
- 26 pupil membership count day. However, elective office includes a
- 27 school board member in a school district that has a pupil
- 28 membership of 2,400 or less, if a candidate committee of a
- 29 candidate for the office of school board member in that school

- 1 district receives an amount in excess of \$1,000.00 or expends an
- 2 amount in excess of \$1,000.00. Elective office does not include a
- 3 federal office except for the purposes of section 57.
- 4 Sec. 7. (1) "Filed" means the receipt by the appropriate
- 5 filing official of a statement or report required to be filed under
- 6 this act.
- 7 (2) "Filer" means a person required to file a statement or
- 8 report under this act.
- **9** (3) "Filing official" means the official designated under this
- 10 act to receive required statements and reports.
- 11 (4) "501(c)(4) organization" means a an organization that
- 12 claims tax-exempt status under section 501(c)(4) of the internal
- 13 revenue code, 26 USC 501, if that organization employs, has a board
- 14 member who is, or is controlled or directed by, any of the
- 15 following:
- 16 (a) A candidate for state elective office.
- 17 (b) An elected official.
- 18 (c) An appointed official for state elective office.
- (d) Any employee, contract employee, or staff member of any of
- 20 the following:
- 21 (i) An elected official.
- 22 (ii) A candidate for a state elective office.
- 23 (iii) An appointed official for a state elective office.
- 24 (e) Any family member of an elected official, candidate for a
- 25 state elective office, or appointed official for a state elective
- 26 office. As used in this subdivision, "family member" means any of
- 27 the following:
- 28 (i) A spouse or ex-spouse.
- 29 (ii) A child, stepchild, grandchild, parent, sibling, niece, or

- 1 nephew.
- 2 (iii) The spouse of a child, stepchild, grandchild, parent,
- 3 sibling, niece, or nephew.
- 4 (5) "527 organization" means an organization that claims tax-
- 5 exempt status under section 527 of the internal revenue code, 26
- 6 USC 527, if that organization employs, has a board member who is,
- 7 or is controlled or directed by, any of the following:
- 8 (a) A candidate for state elective office.
- 9 (b) An elected official.
- 10 (c) An appointed official for a state elective office.
- 11 (d) Any employee, contract employee, or staff member of any of
- 12 the following:
- 13 (i) An elected official.
- 14 (ii) A candidate for a state elective office.
- 15 (iii) An appointed official for a state elective office.
- 16 (e) Any family member of an elected official, candidate for a
- 17 state elective office, or appointed official for a state elective
- 18 office. As used in this subdivision, "family member" means any of
- 19 the following:
- 20 (i) A spouse or ex-spouse.
- 21 (ii) A child, stepchild, grandchild, parent, sibling, niece, or
- 22 nephew.
- 23 (iii) The spouse of a child, stepchild, grandchild, parent,
- 24 sibling, niece, or nephew.
- 25 (6) (4) "Fund raising event" means an event such as a dinner,
- 26 reception, testimonial, rally, auction, or similar affair through
- 27 which contributions are solicited or received by purchase of a
- 28 ticket, payment of an attendance fee, making a donation, or
- 29 purchase of goods or services.

- 1 (7) (5)—"Gift" means a payment, subscription, advance,
- 2 forbearance, rendering, or deposit of money, services, or anything
- 3 of value, unless consideration of equal or greater value is given
- 4 in exchange.
- 5 (8) (6) "Honorarium" means a payment of money to a person
- 6 holding elective office as consideration for an appearance, a
- 7 speech, an article, or any activity related to or associated with
- 8 the performance of duties as an elected official. An honorarium
- 9 does not include any of the following:
- 10 (a) Reimbursement for the cost of transportation,
- 11 accommodations, or meals for the person.
- 12 (b) Wages, salaries, other employee compensation, and expenses
- 13 authorized to be paid by this state or a political subdivision of
- 14 this state to the person holding elective office.
- **15** (c) An award.
- 16 Enacting section 1. This amendatory act takes effect January
- **17** 1, 2026.
- 18 Enacting section 2. This amendatory act does not take effect
- 19 unless Senate Bill No. or House Bill No. 5580 (request no.
- 20 00458'23 *) of the 102nd Legislature is enacted into law.
