A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 213b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 213b. (1) Except as provided in subsections (2) and (3),
- 2 an individual who intentionally and maliciously threatens to
- 3 release, exhibit, or distribute sexually explicit visual material
- 4 of another individual in order to compel or attempt to compel
- 5 another individual to do any act or refrain from doing any act

- 1 against the individual's will with the intent to obtain additional
- 2 sexually explicit visual material or anything else of value is
- 3 guilty of a felony punishable as follows:
- 4 (a) For a first offense, by imprisonment for not more than 5
- 5 years.
- 6 (b) For a second offense, by imprisonment for not more than 10
- 7 years.
- 8 (c) For a third or subsequent offense, by imprisonment for not
- 9 more than 20 years.
- 10 (2) If an individual commits a violation of subsection (1) and
- 11 either of the following factors apply, the individual is guilty of
- 12 a felony punishable by imprisonment for not more than 20 years:
- 13 (a) The victim is less than 18 years of age or a vulnerable
- 14 adult and the individual who committed the violation is more than
- 15 18 years of age and is not a vulnerable adult.
- 16 (b) The victim suffers great bodily injury or death as a
- 17 result of the violation of subsection (1).
- 18 (3) If the individual convicted of a violation of subsection
- 19 (1) is less than 18 years of age, the individual is guilty of a
- 20 misdemeanor punishable by imprisonment for not more than 1 year.
- 21 The court may order behavioral health counseling from an
- 22 appropriate agency or provider as part of an individual's sentence
- 23 under this subsection.

- 25 (a) "Great bodily injury" means bodily injury that causes a
- 26 substantial risk of death, serious or permanent disfigurement, or
- 27 protracted loss or impairment of the function of a bodily member or

- 29 (b) "Nudity" means displaying an individual's genitalia or

- 1 anus or if the individual is a female, her nipples or areola.
- 2 (c) "Sexually explicit visual material" means a photograph or
- 3 video that depicts nudity, erotic fondling, sexual intercourse, or
- 4 sadomasochistic abuse.
- 5 (d) "Vulnerable adult" means that term as defined in section
- 6 145m.
