A bill to amend 2012 PA 615, entitled "Michigan energy assistance act," by amending section 3 (MCL 400.1233).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 3. (1) Subject to state appropriations, not later than
- 2 October 1, 2013, the department shall establish and administer the
- 3 Michigan energy assistance program statewide to provide energy
- 4 assistance to eligible low-income households.
- 5 (2) The department may use funds received from a federal
- 6 energy assistance program and any funds collected or appropriated

- 1 to fund the program. The department shall distribute the funds
- 2 described in this subsection for energy assistance and may use a
- 3 portion of the funds for necessary administrative expenses.
- 4 Necessary administrative expenses shall must be calculated using an
- 5 established cost allocation methodology.
- 6 (3) Energy assistance must prioritize vulnerable populations
- 7 and, as appropriate for the household, include services that will
- 8 enable participants to become or move toward becoming self-
- 9 sufficient. , including assisting Services that assist participants
- 10 in becoming self-sufficient include, but are not limited to,
- 11 providing assistance to help participants in paying their energy
- 12 bills on time, assisting participants in budgeting for and
- 13 contributing to their ability to provide for energy expenses, and
- 14 assisting participants in utilizing energy services to optimize on
- 15 energy efficiency. referral to weatherization or energy waste
- 16 reduction programs and services. By October 1, 2014, each entity
- 17 that carries out a contract with the department under this section
- 18 shall provide or coordinate these services. The department shall
- 19 attempt to coordinate its efforts with the efforts of other state
- 20 departments or agencies to assist low-income households in becoming
- 21 or moving toward becoming self-sufficient and reducing energy
- 22 insecurity.
- 23 (4) The department shall develop a simplified, single
- 24 application for all applicants to use to apply for energy
- 25 assistance under the program. The single application shall must be
- 26 made available to all entities that contract with the department to
- 27 provide services under the program.
- 28 (5) Not later than December 1, 2014, and annually after that,
- 29 thereafter, the department shall provide a report to the

- 3 relating to energy, and the senate and house fiscal agencies on how
- 4 money from the program <del>created in this act</del> was distributed.
- 5 Beginning with the program year that begins October 1, 2025, the
- 6 annual report required under this subsection must be filed no later
- 7 than March 1, 2027.
- 8 (6) The department shall notify participants that they are
- 9 eligible for other services under the program including, but not
- 10 limited to, energy waste reduction products and services offered by
- 11 an energy provider or a home weatherization assistance program.
- 12 Enacting section 1. This amendatory act does not take effect
- 13 unless all of the following bills of the 102nd Legislature are
