June 07, 2023, Introduced by Senators CHANG, MCBROOM, IRWIN, SHINK, SANTANA, WOJNO, BAYER, VICTORY, BELLINO and HUIZENGA and referred to the Committee on Civil Rights, Judiciary, and Public Safety.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"

(MCL 760.1 to 777.69) by adding section 34a to chapter IX.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 CHAPTER IX
2 Sec. 34a. (1) The Michigan sentencing commission is created in
3 the legislative council. The legislative council shall provide the
4 commission with suitable office space, staff, and necessary
5 equipment. The commission consists of the chairperson appointed by

- 1 the governor under subsection (4) and all of the following members:
- 2 (a) Two individuals who are members of the senate, consisting
- ${\tt 3}$ of 1 member from each caucus appointed by the leader of their
- 4 caucus.
- 5 (b) Two individuals who are members of the house of
- 6 representatives, consisting of 1 member from each caucus appointed
- 7 by the leader of their caucus.
- 8 (c) The attorney general or the attorney general's designee,
- 9 who shall serve as a nonvoting member.
- 10 (d) One individual who is a circuit court judge, serving in a
- 11 county with a population of less than 800,000, appointed from a
- 12 list of 3 names submitted by the Michigan Judges Association.
- (e) One individual who is a circuit court judge, serving in a
- 14 county with a population of more than 800,000, appointed from a
- 15 list of 3 names submitted by the Michigan Judges Association.
- 16 (f) One individual who represents law enforcement, appointed
- 17 from a list of 3 names not all of whom are affiliated with the same
- 18 political party, submitted by the Michigan Sheriffs' Association.
- 19 (g) One individual who represents the prosecuting attorneys of
- 20 this state, appointed from a list of 3 names not all of whom are
- 21 affiliated with the same political party, submitted by the
- 22 Prosecuting Attorneys Association of Michigan.
- 23 (h) One individual who represents criminal defense attorneys,
- 24 appointed from a list of 3 names not all of whom are affiliated
- 25 with the same political party, submitted by the Criminal Defense
- 26 Attorneys of Michigan.
- 27 (i) One individual who is a member of a nongovernmental
- 28 nonprofit that serves victims and represents victim service
- 29 providers.

- 1 (j) One individual who was previously incarcerated, who shall 2 serve as a nonvoting member.
- 3 (k) One individual who works in the mental or behavioral 4 health field, who shall serve as a nonvoting member.
- 5 (*l*) One individual appointed from a list of 3 names submitted 6 by the director of the Michigan department of corrections.
- 7 (2) Before January 1, 2024, the speaker of the house of 8 representatives shall appoint 1 of the commission members described 9 in subsection (1)(d) and (e) and the minority leader of the house 10 of representatives shall appoint the remaining commission member. 11 Before January 1, 2024, the senate majority leader shall appoint 1 12 of the commission members described in subsection (1)(f) and (q) 13 and the senate minority leader shall appoint the remaining 14 commission member. Before January 1, 2024, the senate majority 15 leader shall appoint 1 of the commission members described in

subsection (1)(h) and (i) and the senate minority leader shall

appoint the remaining commission member.

(3) Before January 1, 2024, the speaker of the house of representatives and the senate majority leader shall, in consultation with one another, appoint the members described in subsection (1)(h) to (l). If the speaker of the house of representatives and the senate majority leader are unable to agree on an appointment, the chairperson shall appoint a member from among the individuals who are the expressed choices of the speaker of the house of representatives and the senate majority leader. If neither the speaker of the house of representatives nor the senate majority leader express a choice within 30 days of a vacancy on the commission, the chairperson shall appoint the commission member.

29 Members described in subsection (1)(h) to (l) must attest either

- 1 that they affiliate with 1 of the 2 political parties with the
- 2 largest representation in the legislature, and if so, identify the
- 3 party with which they affiliate, or that they do not affiliate with
- 4 either of the major parties. Not less than 1 of the appointments
- 5 made under subsection (1) must be from a different affiliation than
- 6 the other appointments.
- 7 (4) Before January 1, 2024, the governor shall appoint, with
- 8 advice and consent of the senate, 1 member to the Michigan
- 9 sentencing commission who must serve as chairperson. The
- 10 chairperson must be appointed for a term of 4 years. The
- 11 chairperson shall serve as a nonvoting member of the commission.
- 12 The individual appointed as chairperson must have a professional
- 13 background in criminal law.
- 14 (5) Except as otherwise provided in this subsection, the
- 15 commission members must be appointed for terms of 4 years. Of the
- 16 members first serving under subsection (1)(c) to (l), 3 members
- 17 shall serve for 2 years, 4 members shall serve for 3 years, and 3
- 18 members shall serve for 4 years. The members of the commission
- 19 appointed under subsection (1)(a) and (b) must be appointed for
- 20 terms of 2 years.
- 21 (6) A vacancy on the commission caused by the expiration of a
- 22 term or a resignation or death must be filled in the same manner as
- 23 the original appointment. A member appointed to fill a vacancy
- 24 caused by a resignation or death must be appointed for the balance
- 25 of the unexpired term.
- 26 (7) Except for the chairperson, a commission member must not
- 27 receive a salary for being a commission member but must be
- 28 reimbursed for the member's reasonable, actual, and necessary
- 29 expenses incurred in the performance of the member's duties as a

- 1 commission member.
- 2 (8) The commission may establish subcommittees that may
- 3 consist of individuals who are not members of the commission,
- 4 including, but not limited to, experts in matters of interest to
- 5 the commission. A subcommittee member, who is not a member of the
- 6 commission, shall not vote on any recommendations made by the
- 7 commission. A subcommittee member shall not receive a salary for
- 8 the subcommittee member's service on a subcommittee.
- 9 (9) The commission's business must be conducted at public
- 10 meetings held in compliance with the open meetings act, 1976 PA
- 11 267, MCL 15.261 to 15.275.
- 12 (10) A quorum consists of a majority of the members of the
- 13 commission. All commission business must be conducted by not less
- 14 than a quorum.
- 15 (11) A writing prepared, owned, used, in the possession of, or
- 16 retained by the commission in the performance of an official
- 17 function must be made available to the public in compliance with
- 18 the freedom of information act, 1976 PA 442, MCL 15.231 to 15.246.
- 19 Enacting section 1. This amendatory act does not take effect
- 20 unless House Bill No. 4384 of the 102nd Legislature is enacted into
- **21** law.
