## **SENATE BILL NO. 525**

September 26, 2023, Introduced by Senators ALBERT, BELLINO and LINDSEY and referred to the Committee on Economic and Community Development.

A bill to prohibit a public officer of this state or a political subdivision of this state from entering into certain nondisclosure agreements regarding economic development projects; and to provide remedies.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. This act may be cited as the "economic development
  transparency act".
- 3 Sec. 3. As used in this act:
- 4 (a) "Economic development incentive" means a tax incentive,5 payment in lieu of taxes, tax abatement, bond, note, loan, grant,

- 1 rebate, tax increment financing, or any other financial or economic
- 2 assistance from this state or a political subdivision of this

- 4 (b) "Economic development project" means any project in this
- 5 state that is subject to an economic development incentive.
- 6 (c) "Michigan economic development corporation" means that
- 7 term as defined in section 4 of the Michigan strategic fund act,
- 8 1984 PA 270, MCL 125.2004.
- 9 (d) "Nondisclosure agreement" means an agreement or contract
- 10 that includes a provision or clause that provides that 1 or more of
- 11 the following is confidential or that a party to the agreement or
- 12 contract is prohibited from disclosing, discussing, describing, or
- 13 commenting on 1 or more of the following:
- 14 (i) Information related to an economic development project or
- 15 potential economic development project, including, but not limited
- 16 to, all of the following:
- 17 (A) The number of potential jobs to be created or other
- 18 benefits to be conferred on this state by the project.
- 19 (B) The amount of the investment.
- 20 (C) The site location.
- 21 (D) Site selection criteria.
- 22 (E) The identity of the person proposing or conducting the

- 25 (ii) Any information received in connection with the
- 26 consideration or award of an economic development incentive,
- 27 including, but not limited to, information provided by the Michigan

- 1 potential economic development incentive.
- 2 (e) "Political subdivision" means a county, city, village,
- 3 township, or other political subdivision, public corporation,
- 4 authority, or district in this state.
- 5 (f) "Public officer" means an individual who holds an elective
- 6 office of this state or a political subdivision of this state or an
- 7 individual who is appointed to fill a vacancy in an elective office
- 8 of this state or a political subdivision of this state.
- 9 Sec. 5. Notwithstanding any provision of law to the contrary,
- 10 beginning on and after the effective date of this act, a public
- 11 officer shall not enter into a nondisclosure agreement related to a
- 12 potential economic development incentive that directly or
- 13 indirectly utilizes public funds.
- 14 Sec. 7. (1) This act applies to an agreement or contract that
- 15 is entered into, amended, extended, or renewed on or after the
- 16 effective date of this act.
- 17 (2) An agreement or contract, or a provision of an agreement
- 18 or contract, that violates this act is against public policy and
- 19 void and unenforceable.
