A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending section 1137 (MCL 380.1137), as added by 1995 PA 289.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1137. (1) In recognition of the rights of parents and
- 2 legal guardians, the board of a school district , public school
- ${f 3}$ academy, university school, or intermediate school district ${f or}$
- 4 board of directors of a public school academy shall ensure that a
- 5 parent or legal guardian responsible for the care and custody of a

- pupil enrolled in the school district, public school academy, 1
- 2 university school, or intermediate school district, or public
- 3 school academy may do all of the following:
- (a) Review the curriculum, textbooks, and teaching materials 4 5 of the school in which the pupil is enrolled at a reasonable time
- 6 and place and in a reasonable manner. 7
- (b) Be present, to a reasonable degree, and at reasonable
- 8 times and subject to reasonable restrictions, controls, and limits,
- 9 to observe instructional activity in a class or course in which the
- 10 pupil is enrolled and present. As used in this subdivision,
- 11 "instructional activity" does not include testing.
- (c) Beginning with the 2024-2025 school year, cause the pupil 12
- 13 to be enrolled in the grade level that the pupil was enrolled in
- 14 for the immediately preceding school year. By not later than July
- 15 1, 2024 for enrollment for the 2024-2025 school year, and by not
- later than July 1 each year thereafter for enrollment for the 16
- school year following that July 1, to exercise this right, the 17
- 18 parent or legal guardian must submit a written request to the
- 19 school district, intermediate school district, or public school
- 20 academy in which the pupil is enrolled.

- 3 (3) If a request under subsection (1)(c) is received by a

- 8 ensure that, for the school year following that July 1, the pupil

- 23 parent's or legal guardian's right under subsection (1)(c),
- 24 including notice of applicable deadlines under subsection (1)(c),
- 25 is provided to the parents and legal guardians of pupils enrolled
- 26 in the school district, intermediate school district, or public
- 27 school academy.
