Senators Brinks and Nesbitt offered the following concurrent resolution:

- 1 A concurrent resolution of tribute offered as a memorial for
- 2 Michael L. Green, former member of the Michigan Senate and Michigan
- 3 House of Representatives.
- 4 Whereas, It is with great sorrow that the members of this
- 5 Legislature learned about the passing of Mike Green. He will be
- 6 remembered as a dedicated public servant and leader who was
- 7 committed to his constituents in the Thirty-First Senate District
- 8 and the Eighty-Fourth House District; and
- 9 Whereas, Mike Green was born in Risco, Missouri, before moving
- 10 to Michigan. He was a member of the 1966 graduating class of
- 11 Goodrich High School and attended Flint Jr. College. Before being
- 12 elected to the Michigan House of Representatives, Mike Green worked
- 13 for General Motors for nearly three decades; additionally, he

- 1 operated the family farm for 17 years and owned a custom log
- 2 furniture business. Furthermore, Mike Green was elected and served

- 3 as a Tuscola County commissioner for eight years and also worked as
- 4 an aide for a former Senator. Throughout his life, Mike Green's
- 5 dedication to his community was evident from his active
- 6 participation in and leadership over a number of organizations: the
- 7 Tuscola County Cooperative Extension, the Tuscola County Health
- 8 Department, the Thumb Area Commission on Aging, the Thumb Area
- 9 Consortium Joint Executive Council, the Michigan Association of
- 10 Counties, and many others. A devout Baptist, Mike Green was also an
- 11 active member of his religious community the Juniata Baptist
- 12 Church and the Gideons International; and
- 13 Whereas, Mike Green was first elected to the Michigan House of
- 14 Representatives in 1994, where he served three terms. During his
- 15 tenure as a representative, Mike Green served in multiple roles on
- 16 various committees, including serving as the minority vice chair of
- 17 the Agriculture Committee, the vice chair of the Agriculture and
- 18 Forestry Committee, and the chair of the Agriculture and Resource
- 19 Management Committee. In 2010, Mike Green was elected to the
- 20 Michigan Senate, where he served two terms. During his time as a
- 21 senator, Mike Green served with distinction on a number of
- 22 committees, including as the vice chair of the Agriculture
- 23 Committee and, at various times, as chair of the Appropriations
- 24 subcommittee on Agriculture and Rural Development and the
- 25 committees on the Department of Environmental Quality, the
- 26 Department of Natural Resources, and Natural Resources. During his
- 27 time in the Legislature, Mike Green was particularly known as a
- 28 pro-life advocate and a champion for issues concerning autism,
- 29 rural communities, gun ownership, and the outdoors. His passion for

- 1 the outdoors led him to re-establish the bipartisan Legislative
- 2 Sportsmen's Caucus; and
- 3 Whereas, Mike Green is survived by his wife of 56 years,
- 4 Paula, and five children. Additionally, he is survived by twenty-
- 5 two grandchildren. He was preceded in death by a son and grandson,
- 6 who passed away before birth. We offer our condolences to Mike
- 7 Green's loved ones and join them in recognizing his lifetime of
- 8 contributions to the State of Michigan, which will always be
- 9 remembered; now, therefore, be it
- 10 Resolved by the Senate (the House of Representatives
- 11 concurring), That we offer this expression of our highest tribute
- 12 to honor the memory of Michael L. Green, a loyal member of
- 13 Michigan's House of Representatives from 1995 to 2000 and the
- 14 Senate from 2011 to 2018; and be it further
- 15 Resolved, That copies of this resolution be transmitted to the
- 16 Green family as evidence of our lasting esteem for his memory.
