## SENATE CONCURRENT RESOLUTION NO. 19

Senators Brinks and Nesbitt offered the following concurrent resolution:

- 1 A concurrent resolution offered as a memorial for Nancy C.
- 2 Cassis, former member of the Michigan Senate and Michigan House of
- 3 Representatives.
- 4 Whereas, It is with great sorrow that the members of the
- 5 Legislature learned about the passing of Nancy Cassis. She will be
- 6 remembered as a dedicated public servant and leader who was
- 7 committed to her constituents in the Fifteenth Senate District and
- 8 Thirty-Eighth House District; and
- 9 Whereas, Nancy Cassis was born and raised in New York. She
- 10 came to the Midwest to pursue a bachelor's degree at Ohio
- 11 University, from which she graduated in 1966. Afterwards she went
- 12 into teaching. She came to Michigan to get a master's degree from
- 13 the University of Michigan, completing that degree in 1979, and

- 1 continued her studies for an additional year to attain an education
- 2 specialist degree. Thereafter, she began working as a school
- 3 psychologist for Novi Community Schools; and
- Whereas, Nancy got her start in elected office in 1985, when
- 5 she won a seat on the Novi City Council. She served until 1993, and
- 6 then returned to the City Council in 1995. In 1996, she won a
- 7 special election to fill a vacancy in the House, where she served
- 8 until she was elected to the Senate in 2002, serving for the next
- 9 eight years in that chamber; and
- 10 Whereas, Nancy was a trailblazer throughout her time in the
- 11 Legislature. She was the first woman to serve as Chair of the House
- 12 Tax Policy Committee. In 1999, she was named Legislator of the Year
- 13 by the National Republican Legislators' Association. Myriad other
- 14 groups, such as the Michigan Credit Union League, Michigan Soft
- 15 Drink Association, Michigan Manufacturers Association, Michigan
- 16 School Psychologists, Small Business Association of Michigan, and
- 17 Building Owners and Manufacturers, recognized her with awards for
- 18 her contributions in the Legislature. Immediately upon her arrival
- 19 in the Senate, she was named Chair of the Finance Committee, a role
- 20 she would retain throughout her Senate service; and
- 21 Whereas, Nancy's signature issue in the Legislature, as
- 22 demonstrated by her pathbreaking committee service, was public
- 23 finance. She sponsored Michigan's original earned income tax
- 24 credit. When the Legislature was looking for a way to replace the
- 25 former Single Business Tax, she sponsored the Michigan Business Tax
- 26 Act to replace it. Nancy considered her most significant
- 27 achievements to be passing legislation to ensure accountability and
- 28 transparency in the subsidies and tax credit programs provided by
- 29 the Michigan Economic Growth Authority and Michigan Film Office.

- 1 Her interest in taxation extended to personal finances more
- 2 generally and saw her sponsor the Social Security Number Privacy
- 3 Act, a vital measure in protecting the privacy and credit rating of

- 4 Michigan residents; and
- 5 Whereas, In addition to chairing the House Tax Policy
- 6 Committee and the Senate Finance Committee, Nancy served on many
- 7 other committees in the chambers. These included the House Mental
- 8 Health Committee; House Urban Policy and Economic Development
- 9 Committee; House Energy and Technology Committee; House Family and
- 10 Children Services Committee; House Senior Health, Security and
- 11 Retirement Committee; House Redistricting and Elections Committee;
- 12 Senate Education Committee; Senate Government Operations and Reform
- 13 Committee; Senate Technology and Energy Committee; Senate Banking
- 14 and Financial Institutions Committee; and Joint Select Committee on
- 15 Business Competitiveness; and
- 16 Whereas, After completing her time in the Senate, Nancy
- 17 retired to Florida. There, she and her husband, Victor, achieved
- 18 what so many Michigan residents dream of: living near the ocean.
- 19 With the backdrop of a stunning view of the Atlantic, she spent her
- 20 retirement years enjoying the company of her three siblings, seven
- 21 children, and 13 grandchildren; and
- Whereas, Upon Nancy Cassis's passing, we offer our condolences
- 23 to her loved ones. Nancy Cassis's contributions to the Michigan
- 24 Legislature and the state of Michigan will be remembered; now,
- 25 therefore, be it
- Resolved by the Senate (the House of Representatives
- 27 concurring), That we offer this expression of our highest tribute
- 28 to honor the memory of Nancy Cassis, a member of the House of
- 29 Representatives from 1996 to 2002, and of the Senate from 2003 to
