HOUSE RESOLUTION NO.15

Rep. Edwards offered the following resolution:

- 1 A resolution to declare January 15, 2023, as Alpha Kappa Alpha
- 2 Sorority, Incorporated, Founders' Day in the state of Michigan.
- 3 Whereas, Alpha Kappa Alpha Sorority, Incorporated was founded
- 4 on the campus of Howard University on January 15, 1908, by nine
- 5 junior and senior students, under the leadership of Ethel Hedgeman
- 6 Lyle and Lavinia Norman, Margaret Flagg, Lucy Slowe, Marie
- 7 Woolfolk, Beulah Burke, Lillie Burke, Anna Easter Brown, and
- 8 Marjorie Hill, who, collectively, sought to form an association of
- 9 women students through which their talents and strengths would be
- 10 organized for the mutual benefit of all. This group later expanded
- 11 to include seven sophomores (Joanna Berry, Norma Boyd, Ethel Jones,
- 12 Sara Merriweather, Alice Murray, Carrie Snowden, and Harriet Terry)
- 13 who were asked to join to ensure the continuity of the sorority;

- 2 Whereas, This year marks the 115th anniversary of its
- 3 founding, Alpha Kappa Alpha Sorority, Incorporated, has its place
- 4 in history as the world's first and oldest Greek-letter
- 5 organization established by African-American college-educated
- 6 women; and
- 7 Whereas, Throughout its history, Alpha Kappa Alpha Sorority,
- 8 Incorporated, has led conversations, advocacy, and actions to
- 9 address needs in African-American communities related to education
- 10 inequities, disparate health care, civil rights, economic
- 11 empowerment, job training, and numerous social justice issues; and
- 12 Whereas, Alpha Kappa Alpha Sorority, Incorporated, has over
- 13 325,000 members and more than 1,000 chapters located throughout the
- 14 United States, West Africa, the Bahamas, the Virgin Islands, Japan,
- 15 Korea, and Germany. Over 30 of these chapters are in communities
- 16 and on college and university campuses in the great state of
- 17 Michigan; and
- 18 Whereas, Alpha Kappa Alpha Sorority, Incorporated, members in
- 19 the state have made numerous contributions to the educational,
- 20 civic, and well-being of Michigan's citizens and communities
- 21 through its work on issues including economic development,
- 22 community development, at-risk youth, homelessness, domestic
- 23 violence, breast cancer awareness, education, personal money
- 24 management, and entrepreneurship; and
- 25 Whereas, Alpha Kappa Alpha Sorority, Incorporated, members in
- 26 the state can count among their achievement's successful
- 27 collaborations with organizations such as the Salvation Army, Boys
- 28 and Girls Clubs, rescue missions, American Cancer Society, Susan G.
- 29 Komen Foundation, Meals on Wheels, numerous food banks, and

- 2 Resolved, That the members of this legislative body declare
- 3 January 15, 2023, as Alpha Kappa Alpha Sorority, Incorporated,
- 4 Founders' Day in the state of Michigan; and be it further;
- 5 Resolved, That copies of this resolution be transmitted to the
- 6 national headquarters for Alpha Kappa Alpha Sorority, Incorporated,
- 7 and its Great Lakes Regional Director's office.
