## HOUSE RESOLUTION NO. 184

Reps. Markkanen, Hill, Prestin and Cavitt offered the following resolution:

- A resolution to vehemently oppose the transfer of mailprocessing operations from the Iron Mountain Processing and
- 3 Distribution Center to the Green Bay Processing and Distribution
- 4 Center in Wisconsin.
- 5 Whereas, The United States Postal Service has a long and
- 6 venerable tradition of serving as a great equalizer between the
- 7 people of our nation. Both the Articles of Confederation and the
- 8 Constitution of the United States gave Congress the power to
- 9 establish a system of post offices, and a Post Office Department
- 10 was first established by the Second Continental Congress in 1775,
- 11 with Benjamin Franklin appointed to serve as the Postmaster
- 12 General. Throughout its 250-year history, the Post Office has

- 1 chosen time and time again to prioritize service over profit, from
- 2 President Washington's support for the subsidization of
- 3 stagecoaches in the 1780s, to the construction of money-losing
- 4 postal routes to encourage settlement in the west during the mid-
- 5 19th century, to the creation of the Pony Express to deliver the
- 6 mail through extreme environments in 1860, to the elimination of
- 7 price differences based on the distance a letter was to travel in
- 8 1863. While free home delivery began in cities in 1863, it was not
- 9 initially offered in rural areas, though they paid the same rates.
- 10 After initial experiments showed how happy rural customers were to
- 11 be given the same attention as city-dwellers, rural free delivery
- 12 became a permanent service in 1902. It is the mission of the United
- 13 States Postal Service "to bind the Nation together through the
- 14 personal, educational, literary, and business correspondence of the
- 15 people"; and
- 16 Whereas, The Post Office is a service that we, as a society,
- 17 have chosen to provide to our people. There is no constitutional
- 18 mandate that the Post Office be run as a profitable business
- 19 enterprise; to the contrary, our history shows that we have
- 20 repeatedly used the Post Office to ensure that every American, no
- 21 matter where they live, is connected through the post. The people
- 22 can choose the level of postal service that they want the United
- 23 States Postal Service to provide, and they can decide what costs
- 24 they are willing to bear to provide that service; and
- 25 Whereas, Contrary to the desires of many that the United
- 26 States Postal Service put service first, there are those who insist
- 27 that it must be run like a business. The "Delivering for America"
- 28 plan, published in March 2021, emphasizes the financial viability
- 29 of the Postal Service, with a focus on raising enough revenue to

- 1 cover their operating costs and fund new investments. The plan
- 2 proudly proclaims that it will enable the United States Postal
- 3 Service to operate with a positive net income, and the most recent
- 4 report boasts that it has reduced projected ten-year losses from
- 5 160 billion dollars to 70 billion dollars. These publications read
- 6 like a corporate marketing pitch, establishing goals such as a
- 7 "more rational pricing approach," a "stable and empowered
- 8 workforce" and a "bold approach to growth, innovation and continued
- 9 relevance." What these profit-minded advocates seemingly fail to
- 10 recognize is that lower-quality service and higher prices drive
- 11 customers away, decreasing use of the postal service and thus
- 12 decreasing revenue, while simultaneously undermining the Postal
- 13 Service's mission of binding the nation together; and
- 14 Whereas, The United States Postal Service's focus on financial
- 15 optimization has already had negative impacts on those living in
- 16 rural areas, such as Michigan's Upper Peninsula. Local post offices
- 17 have changed the time when mail is gathered for delivery from the
- 18 afternoon to the early morning, meaning that a piece of mail
- 19 dropped off during the day will remain at the post office for far
- 20 longer before the shipping process begins. In practical effect,
- 21 this adds one day to shipping times even while allowing the Postal
- 22 Service to deny having done so for accounting purposes.
- 23 Additionally, one-day Priority Mail Express shipping, which was
- 24 available as recently as early January 2024, is no longer available
- 25 from the UP to anywhere in Michigan; instead, citizens are being
- 26 charged the same rate for two-day shipping. Combined with the
- 27 change in collection time above, next-day shipping has essentially
- 28 been transformed into three-day shipping. This is extremely
- 29 problematic for businesses and health departments that need to

- 1 collect samples of drinking water and have them delivered to a
- 2 laboratory for bacterial testing within 24 hours of sampling.
- 3 Delays in shipping also have negative consequences for patients who
- 4 receive medications through the mail, for people who need to ensure
- 5 their bills are paid on time, and for businesses delivering frozen
- 6 foods such as the UP's beloved pasties. Focusing too much on the
- 7 postal network as a whole while ignoring the importance of timely
- 8 local shipping is not modernization; it is regression. The people
- 9 of the Upper Peninsula want what's best for their communities, not
- 10 what's best for the pocketbooks of those in Washington; and
- 11 Whereas, In January 2024, the United States Postal Service
- 12 announced plans to transfer some mail processing services,
- 13 including outgoing mail operations, from the Iron Mountain
- 14 Processing and Distribution Center in Kingsford, Michigan, to the
- 15 Green Bay Processing and Distribution Center in Wisconsin. The
- 16 Postal Service has justified this plan based on the fact that a
- 17 majority of the mail and packages sent from the Iron Mountain area
- 18 are destined for locations outside the local area. While this might
- 19 make sense from the standpoint of the Postal Service as a
- 20 nationwide business, it does not make sense for the people of the
- 21 Upper Peninsula, for whom timely local delivery is essential. The
- 22 notices that have been published about this plan assure that, while
- 23 five craft employee positions will be eliminated, no management
- 24 positions will be eliminated. But the notices also indicate that
- 25 there will be reassignments, which means that some employees could
- 26 be left without a job if they are unwilling to be reassigned to a
- 27 post office far away. Furthermore, recent changes to the Iron
- 28 Mountain facility may have led to inaccurate conclusions about the
- 29 need for it, stacking the deck so that the evidence would support

- 1 the conclusion the government was looking for. The capacity of the
- 2 Green Bay facility to handle the mail from the Iron Mountain area
- 3 is curiously left out of the government's preliminary findings.
- 4 When similar notices across the country all use identical,
- 5 buzzword-riddled language about efficiency, cost-effectiveness,
- 6 modern strategies, and "rightsizing" the postal workforce, it
- 7 becomes difficult to trust that they have made a careful, informed
- 8 decision about the proper level of services to provide at the Iron
- 9 Mountain facility; now, therefore, be it
- 10 Resolved by the House of Representatives, That we vehemently
- 11 oppose the transfer of mail processing operations from the Iron
- 12 Mountain Processing and Distribution Center to the Green Bay
- 13 Processing and Distribution Center in Wisconsin; and be it further
- 14 Resolved, That copies of this resolution be transmitted to the
- 15 Governor of Michigan, the President of the United States, the
- 16 President of the United States Senate, the Speaker of the United
- 17 States House of Representatives, the members of the Michigan
- 18 congressional delegation, and the United States Postmaster General.
