Overview

House Bill 4328 (H-1) contains supplemental appropriation adjustments for the Department of State Police. Appropriation adjustments total \$100.0 million Gross, \$100.0 million GF/GP.

STATE POLICE

1. Storm Disaster Relief Grants

Includes \$75.0 million GF/GP for storm disaster relief grants. Funding would be allocated by the Department of State Police to counties to assist with identifying and securing disaster assistance for individual residents, businesses, and communities that have realized a significant financial hardship caused by recent storm damage.

2. Disaster Relief Contingency Supplement

Includes \$25.0 million GF/GP for storm disaster relief grants. Funding would be allocated by the Department of State Police to counties to assist with identifying and securing disaster assistance for individual residents, businesses, and communities that have realized a significant financial hardship caused by recent storm damage. Boilerplate requires funding to be transferred to the Storm Disaster Relief Grants line item before expenditure.

FY 2024-25 Supplemental Boilerplate Items

GENERAL SECTIONS

Sec. 201. State Spending and State Appropriations Paid to Local Units of Government

Lists amount of state spending from state sources included in the bill and amount of state spending to be paid to local units of government.

Sec. 202. Appropriations Subject to Management and Budget Act

Subjects appropriations to the Management and Budget Act, 1984 PA 431.

Sec. 203. State Administrative Board Transfers

Authorizes the legislature, by a concurrent resolution adopted by a majority of members elected to and serving in each house, to inter-transfer funds if State Administrative Board transfers funds.

STATE POLICE

Sec. 301. Storm Disaster Relief Grants

- (1) requires funding to be allocated by the department to counties on a first-come, first-served basis, before allocating funds appropriated for disaster relief contingency supplement, to be used to assist individual residents, businesses, and communities with disaster assistance efforts; 50% of qualified expenses would be reimbursed immediately upon the effective date of the bill; the remaining 50% of qualified expenses would be reimbursed six months after the effective date of the bill and remaining funds would be prorated.
- (2) requires funding to be used for the following purposes: to meet state match funding requirements for receipt and expenditure of federal funding made available; emergency actions needed to protect life, property, public health, and public safety, including shelter, emergency supplies, and debris clean-up, removal, and disposal; energy assistance, including paying heating and electricity bills, preventing shutoffs, and providing crisis assistance; and repair or replacement of disaster-damaged infrastructure, facilities, and businesses.
- (3) requires funding allocated to individuals to be used to cover qualified storm damage related expenses, including debris clean-up, removal, and disposal, and repair of damages to the individual's dwelling and immediate curtilage.

Sec. 302. Disaster Relief Contingency Supplement

Requires any remaining funds, after expenses have been fully reimbursed under Sec. 301, to be allocated to address storm damage on land owned by the state and DNR, and to reimburse electric cooperatives regulated under the Electric Cooperative Member-Regulation Act, for qualified expenses as a result of storm damage; specifies how funds are to be disbursed.

Sec. 303. Expenditure of Funds after Transfer

Requires funds appropriated for Disaster Relief Contingency Supplement to be transferred to the Storm Disaster Relief Grants line item to be expended.

Sec. 304. Work Project Appropriation Designation

Requires unexpended funds to be designated as a work project account; specifies that the purpose of the work project account is to assist individual residents, businesses, and communities with disaster assistance efforts; specifies the total cost of the work project; and specifies that the tentative completion date of the work project is September 30, 2026.
