Major Boilerplate Changes from FY 2024-25 Year-to-Date:

- 1. **Deleted Sections.** The Senate deleted five sections, which include: **1100** (Charter School Transparency Database), **1101** (Mental Health Training), **1102** (Community Health Worker Career Center), **1103** (School Infrastructure and Consolidation Administration), and **1104** (Michigan Test for Teacher Certification Reimbursement).
- 2. New Sections. The Senate added five new sections, which include: 220 (General Fund Prioritization), 221 (Unenforceability Declaration Report), 224 (Federal Policy Change Report), 704 (Foster Care Oversight), 705 (Media Literacy Training), and 802 (Michigan Electronic Library System Appropriation.
- 3. Michigan Made Goods and Services. The Senate modified the section directing expenditures to American, Michigan, and veteran owned business to also include businesses that employ union members. (Sec. 205)
- **4. State Fiscal Recovery Fund Re-Allocation.** The Senate modified the section directing the use of Federal State Fiscal Recovery Funds to require a report on any funds that are projected to lapse. (**Sec. 223**)
