A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding sections 17773, 20817, and 21539.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 17773. (1) Any unused portion of a facility-provided drug that is dispensed for an ophthalmic surgical procedure performed on or for ophthalmic medical care provided to a patient in a hospital

- 1 or freestanding surgical outpatient facility licensed under article
- 2 17 must be offered to the patient on the patient's discharge from
- 3 the hospital or freestanding surgical outpatient facility if all of
- 4 the following apply:
- 5 (a) The hospital or freestanding surgical outpatient facility
- 6 orders the facility-provided drug for an ophthalmic surgical
- 7 procedure for the patient that is performed on an in-patient basis
- 8 or for ophthalmic medical care that the patient receives from the
- 9 hospital or freestanding surgical outpatient facility on an in-
- 10 patient basis.
- 11 (b) The facility-provided drug is administered to the patient
- 12 at the hospital or freestanding surgical outpatient facility.
- 13 (c) The unused portion of the facility-provided drug is
- 14 required for the patient's continued treatment.
- 15 (2) If a pharmacist, rather than a dispensing prescriber,
- 16 dispenses a facility-provided drug that is offered to a patient
- 17 under subsection (1), the pharmacist shall ensure that the drug is
- 18 provided to the patient in a container that is labeled in the same
- 19 manner as required in section 17745(7) for a drug dispensed by a
- 20 dispensing prescriber.
- 21 (3) The prescriber of the facility-provided drug shall counsel
- 22 the patient on the directions for the patient's use of the
- 23 facility-provided drug. If a pharmacist dispenses the facility-
- 24 provided drug, any counseling requirement on the pharmacist is
- 25 waived.
- 26 (4) As used in this section, "facility-provided drug" means a
- 27 drug that meets both of the following requirements:
- 28 (a) The drug is an eye drop or eye ointment.
- 29 (b) The drug is not a pharmaceutical compounded under section

- 2 Sec. 20817. A freestanding surgical outpatient facility shall
- 3 comply with section 17773.
- 4 Sec. 21539. A hospital shall comply with section 17773.
