THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

TITLE

An act to provide protection to employees who report a

violation, planned violation, or suspected violation of state,

local, or federal law; to provide protection to employees who

- participate in hearings, investigations, legislative inquiries, or
 court actions; and to prescribe remedies and penalties.
- 3 Sec. 1. As used in this act:
- 4 (a) "Employee" means a person an individual who performs a
 5 service for wages or other remuneration under a contract of hire,
 6 written or oral, express or implied. Employee includes a all of the
 7 following:
- 8 (i) A person employed by the this state or a political
 9 subdivision of the this state, except not including the state
 10 classified civil service.
- 11 (ii) An independent contractor.
- 12 (iii) A prospective employee who previously engaged in a 13 protected activity described in section 2.
- (c) "Person" means an individual, sole proprietorship,partnership, corporation, association, or any other legal entity.
- (d) "Public body" means all of the following:
- 20 (i) A state officer, employee, agency, department, division,
 21 bureau, board, commission, council, authority, or other body in the
 22 executive branch of state government.
- (ii) An agency, board, commission, council, member, or employeeof the legislative branch of state government.
- (iii) A county, city, township, village, intercounty, intercity,
 or regional governing body, a council, school district, special
 district, or municipal corporation, or a board, department,
- 28 commission, council, agency, or any member or employee thereof.
- 29 (iv) Any other body which that is created by state or local

- 6 Sec. 2. An employer shall not discharge, demote, suspend,
- 7 threaten, or otherwise discriminate against an employee regarding
- 8 the employee's promotion, compensation, terms, conditions,
- 9 location, or privileges of employment or fail or refuse to hire an
- 10 employee because the employee, or a person acting on behalf of the
- 11 employee, reports does any of the following:
- 12 (a) Reports or is about to report, verbally or in writing, a
- 13 violation, planned violation, or a suspected violation of a law or
- 14 regulation or rule promulgated pursuant to a law of this state, a
- 15 political subdivision of this state, or the United States to a
- 16 supervisor or public body, unless the employee knows that the
- 17 report is false. τ
- 18 (b) Provides information to, testifies before, or otherwise
- 19 participates in an investigation, hearing, or inquiry held by a
- 20 public body regarding a violation, planned violation, or suspected
- 21 violation described in subdivision (a), or a court action, or
- 22 because an employee is requested by a public body to provide
- 23 information to, testify before, or otherwise participate in an
- 24 investigation, hearing, or inquiry held by that public body, or a
- 25 court action.
- 26 (c) Protests participating, or refuses to participate, in a
- 27 violation, planned violation, or suspected violation described in
- 28 subdivision (a).

29 Sec. 3. (1) A person who that alleges a violation of this act

- 1 may bring a civil action for appropriate injunctive relief or
- 2 actual damages, or both, within 90 days not more than 2 years after
- 3 the occurrence of the alleged violation of this act. A person that
- 4 brings an action under this subsection may demand a jury trial.
- 5 (2) An action commenced pursuant to brought under subsection
- 6 (1) may be brought in the circuit court for the county where the
- 7 alleged violation occurred, the county where the complainant
- 8 resides, or the county where the person against whom the civil
- 9 complaint is filed resides or has his or her where the person's
- 10 principal place of business is located.
- 11 (3) As used in subsection (1), "damages" means damages for
- 12 injury or loss caused by each violation of this act, including
- 13 reasonable attorney fees.
- 14 (4) An employee shall show by clear and convincing evidence
- 15 that he or she the employee, another employee, or a person acting
- 16 on his or her the employee's behalf reported or was about to
- 17 report, verbally or in writing, a violation, planned violation, or
- 18 a—suspected violation of a law of this state, a political
- 19 subdivision of this state, or the United States to a supervisor or
- 20 a public body.
- 21 Sec. 4a. If this state recovers money as the result of an
- 22 employee reporting a violation, planned violation, or suspected
- 23 violation under section 2, this state shall pay 30% of the money
- 24 recovered to the employee who first reported the violation, planned
- 25 violation, or suspected violation under section 2(a).
- 26 Sec. 5. (1) A person who that violates this act shall be
- 27 liable for is subject to a civil fine of not more than
- \$500.00.\$10,000.00 for each separate violation.
- 29 (2) A civil fine which is ordered pursuant to this act shall

- 1 must be submitted to the state treasurer for deposit in the general
- 2 fund.
