SENATE BILL NO. 161

March 18, 2025, Introduced by Senator BUMSTEAD and referred to Committee on Labor.

A bill to amend 1969 PA 317, entitled "Worker's disability compensation act of 1969," by amending section 405 (MCL 418.405), as amended by 2021 PA 129.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 405. (1) For a full-time, part-time, paid on-call, or

volunteer member of a fully paid—fire department of an airport

operated by a county, public airport authority, or state university

or college; a full-time, part-time, or paid on-call member of a

fully paid fire or police department of a city, township, or

village; employed and compensated upon a full-time basis; a full-1 2 time, part-time, paid on-call, or volunteer member of a fully paid fire or public safety department of a city, township, or village or 3 a public fire authority; employed and compensated upon a full-time 4 5 basis; a county sheriff and the deputies of the county sheriff; a 6 member of the state police; a conservation officer; a forest fire 7 officer; or an officer of the motor carrier enforcement division of the department of state police, "personal injury" includes 8 9 respiratory and heart diseases -or illnesses resulting therefrom, 10 from respiratory and heart diseases that develop or manifest 11 themselves during a period while the member of the department is in 12 the active service of the department and that result from the performance of duties for the department. 13 14 (2) A full-time member, and, beginning January 1, 2022 for a 15 cancer described in this subsection diagnosed on or after January 16 1, 2022, a part-time, paid on-call, or volunteer member, of a fire department or public fire authority, and, beginning January 1, 2022 17 18 for a cancer described in this subsection diagnosed on or after 19 January 1, 2022, a former member who was a full-time, part-time, 20 paid on-call, or volunteer member of a fire department or public fire authority, who has or had 60 months or more active service in 21 the department or public fire authority at the time the cancer 22 23 manifests, itself, and who is or was exposed to the hazards 24 incidental to fire suppression, rescue, or emergency medical 25 services in the performance of his or her the member's work-related duties with the department or authority shall suspend a claim he or 26 27 she the member or former member may have against his or her the member's or former member's employer under this act and may claim 28

- 14 officer's employer under this act and may claim like benefits from
- 15 the Christopher R. Slezak first responder presumed coverage fund
- 16 created under subsection (6) for any respiratory tract, bladder,
- 17 skin, brain, kidney, blood, thyroid, testicular, prostate, or
- 18 lymphatic, ovarian, breast, or non-HPV cervical cancer. The cancers
- 19 described in this subsection are presumed to arise out of and in
- 20 the course of employment only with respect to a claim against the
- 21 fund and in the absence of non-work-related causation or specific
- 22 incidents that establish a cause independent of the employment.
- 23 Neither mere Mere evidence that the condition was preexisting, nor
- 24 or an abstract medical opinion that the employment was not the
- 25 cause of the disease or condition, is **not** sufficient to overcome
- 26 the presumption for purposes of a claim against the Christopher R.
- 27 Slezak first responder presumed coverage fund. The presumption
- 28 under this subsection may be rebutted by scientific evidence that
- 29 the member or former member of the fire department or public fire

- 1 authority was a substantial and consistent user of cigarettes or
- 2 other tobacco products within the 10 years immediately preceding
- 3 the date of injury, and that this use was a significant factor in
- 4 the cause, aggravation, or progression of the cancer. The
- 5 suspension of the member's or former member's claim against his or
- 6 her the member's or former member's employer under this subsection
- 7 is in effect only during the period the member receives like
- 8 benefits from the Christopher R. Slezak first responder presumed
- 9 coverage fund. If a redemption agreement between the Christopher R.
- 10 Slezak first responder presumed coverage fund and the claimant is
- 11 approved, the suspension of a claim against an employer under this
- 12 subsection continues indefinitely. A claimant may not receive
- 13 benefits covering the same time period from both the Christopher R.
- 14 Slezak first responder presumed coverage fund and the employer. The
- 15 presumption created in this subsection applies only to a claim for
- 16 like benefits against the Christopher R. Slezak first responder
- 17 presumed coverage fund. For purposes of a claim against the
- 18 Christopher R. Slezak first responder presumed coverage fund
- 19 created under subsection (6), a fire department or public fire
- 20 authority is considered the employer of a volunteer member.
- 21 (3) Respiratory and heart diseases or illnesses resulting
- 22 therefrom from respiratory and heart diseases as described in
- 23 subsection (1) are presumed to arise out of and in the course of
- 24 employment in the absence of evidence to the contrary.
- 25 (4) As a condition precedent to filing an application for
- 26 benefits, a claimant described in subsection (1) or a claimant
- 27 under subsection (2) must first apply for and do all things
- 28 necessary to qualify for any pension benefits to which he or she,
- 29 the claimant, or his or her the claimant's decedent, may be

- 1 entitled or must demonstrate that he or she, the claimant, or his
- 2 or her the claimant's decedent, is ineligible for any pension
- 3 benefits. If a final determination is made that pension benefits
- 4 will not be awarded or that the claimant or his or her the
- 5 claimant's decedent is ineligible for any pension benefits, then
- 6 the designation of "personal injury" as provided in subsection (1)
- 7 or the presumption under subsection (2) applies. The employer,
- 8 employee, member, or former member described in subsection (2) may
- 9 reguest 2 copies of the determination denying pension benefits, 1
- 10 copy of which must be filed with the workers' compensation agency
- 11 upon on request.
- 12 (5) If an employee a member described in subsection (1) or (2)
- 13 or a former member described in subsection (2) is eligible for any
- 14 pension benefits, that eligibility does not prohibit the employee
- 15 member or dependents of that employee member from receiving
- 16 benefits under section 315 for the medical expenses or portion of
- 17 medical expenses that are not provided for by the pension program.
- 18 (6) The Christopher R. Slezak first responder presumed
- 19 coverage fund is created as a separate fund in the state treasury.
- 20 The state treasurer may receive money or other assets from any
- 21 source for deposit into the fund. The state treasurer shall direct
- 22 the investment of the fund. The state treasurer shall credit to the
- 23 fund interest and earnings from fund investments. The director
- 24 shall be the administrator of the fund for auditing purposes. The
- 25 director shall expend money from the fund only for the purpose of
- 26 paying claims authorized under subsection (2) and costs of
- 27 administration. The department of treasury shall cause to be paid
- 28 from the Christopher R. Slezak first responder presumed coverage
- 29 fund those amounts and at those times as are prescribed by the

- 1 director to pay claims under subsection (2) pursuant to in
- 2 accordance with this subsection and subsection (7). Money in the
- 3 fund at the close of the fiscal year remains in the fund and does
- 4 not lapse to the general fund. If there is insufficient money in
- 5 the fund to pay claims authorized under subsection (2), claims that
- 6 are approved but not paid must be paid if fund revenues become
- 7 available, and those claims must be paid before subsequently
- 8 approved claims. The director shall develop and implement a process
- 9 to notify the legislature that money in the Christopher R. Slezak
- 10 first responder presumed coverage fund may be insufficient to cover
- 11 future claims when the director reasonably believes that within 60
- 12 days the money in the fund will be insufficient to pay claims. The
- 13 process must, at a minimum, do all of the following:
- 14 (a) Identify a specific date by which the money in the fund
- 15 will become insufficient to pay claims.
- (b) Outline a clear process indicating the order in which
- 17 claims pending with the fund will be paid.
- 18 (c) Outline a clear process indicating the order in which
- 19 claims that were pending with the fund when money became
- 20 insufficient will be paid, if money subsequently becomes available.
- 21 (7) The director shall develop the application, approval, and
- 22 compliance process necessary to operate and manage the Christopher
- 23 R. Slezak first responder presumed coverage fund. The director
- 24 shall develop and implement the use of an application form to be
- 25 used by a claimant for benefits payable by the fund under
- 26 subsection (2). When a claim under subsection (2) is received, the
- 27 director shall notify the employer against whom a claim is
- 28 suspended or the carrier. The employer or carrier may access all
- 29 information the agency receives respecting the claim and may

- 1 request that the agency obtain specific additional information. The
- 2 fund standards, guidelines, templates, and any other forms used by
- 3 the director to implement the Christopher R. Slezak first responder
- 4 presumed coverage fund must be posted and maintained on the
- 5 department's website. The director shall review and consider claims
- 6 in the order in which they the claims are received and shall
- 7 approve or deny a claim within not later than 30 days after receipt
- 8 of the claim.
- 9 (8) The director shall submit an annual report to the state
- 10 budget director and the senate and house of representatives
- 11 standing committees on appropriations not later than April 1 of
- 12 each year that includes, but is not limited to, all of the
- 13 following:
- 14 (a) The total number of claims received under the Christopher
- 15 R. Slezak first responder presumed coverage fund in the immediately
- 16 preceding calendar year.
- 17 (b) The number of claims approved and the total dollar amount
- 18 of claims paid by the Christopher R. Slezak first responder
- 19 presumed coverage fund in the immediately preceding calendar year.
- 20 (c) The costs of administering the Christopher R. Slezak first
- 21 responder presumed coverage fund in the immediately preceding
- 22 calendar year.
- 23 (9) By March 31 of each year, the worker's compensation agency
- 24 shall report to the chairs of the appropriations committees of the
- 25 senate and the house of representatives the estimated amount of
- 26 both of the following:
- 27 (a) The anticipated cost of benefits in the next fiscal year
- 28 for claims authorized under subsection (2) and payable by the
- 29 Christopher R. Slezak first responder presumed coverage fund.

(b) The amount of any anticipated shortfall in the Christopher
 R. Slezak first responder presumed coverage fund that would prevent
 payment of claims under subsection (6) for the current fiscal year.
 (10) The Christopher R. Slezak first responder presumed
 coverage fund has the same rights under this act as an employer or

carrier.
