SENATE BILL NO. 295

May 13, 2025, Introduced by Senators VICTORY, WEBBER, SINGH, SHINK, CHANG, DALEY, MCMORROW, DAMOOSE, WOJNO and SANTANA and referred to Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1170c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1170c. (1) By not later than December 31, 2025, the
- 2 department, in consultation with water safety experts, shall
- 3 develop or adopt, and make available to school districts and public
- 4 school academies, a model program of instruction on water safety.
- 5 The model program of instruction on water safety must include, at a
- 6 minimum, all of the following topics, as appropriate:
 - (a) The proper use of flotation devices.

- 1 (b) Awareness of water conditions.
- 2 (c) The proper supervision of swim areas.
- 3 (d) Safe behaviors in and around the water.
- 4 (e) The importance of pool barriers and fencing.
- 5 (f) The importance of water safety and swim skills training.
- 6 (g) The importance of avoiding alcohol and substance use with 7 water recreation.
- 8 (h) The importance of cardiopulmonary resuscitation for 9 drowning victims and the importance of administering 10 cardiopulmonary resuscitation.
- 11 (2) The department, in consultation with water safety experts, 12 shall review the model program of instruction on water safety under 13 subsection (1) at least once every year and shall update and revise 14 the model program of instruction on water safety as needed.
 - (3) Beginning in the 2026-2027 school year, the board of a school district or board of directors of a public school academy shall ensure that each student who is enrolled in the school district or public school academy receives age- and grade-appropriate instruction on water safety that includes, at a minimum, the topics described in subsection (1). The water safety instruction must be provided as part of a physical education course. Each school district and public school academy may customize the instruction on water safety based on geographic characteristics and other special circumstances applicable to the school district or public school academy.
- 26 (4) By not later than July 1, 2026, the department of health
 27 and human services shall develop, and provide to the department, an
 28 informational notice in English, Spanish, and Arabic containing
 29 information and best practices regarding water safety.

- 1 (5) The department shall share the informational notice 2 developed under subsection (4) with all public and nonpublic 3 schools.
- 4 (6) Beginning July 1, 2026, the department of health and human 5 services shall update annually the informational notice developed 6 under subsection (4) to account for any change in water safety best 7 practices. The updated notice must be provided annually to the 8 department by not later than July 1.
- 9 (7) Beginning October 1, 2026, and every October 1 thereafter, 10 the board of a school district or intermediate school district, the 11 board of directors of a public school academy, or the governing 12 body of a nonpublic school shall distribute the informational 13 notice developed under subsection (4) to the parent or legal 14 quardian of each student enrolled in the school district, 15 intermediate school district, public school academy, or nonpublic school. The informational notice may be distributed electronically 16 17 or by mail.
- 18 (8) By not later than October 1, 2026, the department shall
 19 post the English, Spanish, and Arabic versions of the informational
 20 notice developed under subsection (4) on the department's website.
 - (9) By not later than October 1, 2026, the board of a school district or intermediate school district, the board of directors of a public school academy, or the governing body of a nonpublic school shall post links to the department webpages described in subsection (8) on the website of the school district, public school academy, or nonpublic school.
- 27 (10) The department, the department of health and human 28 services, a school district, an intermediate school district, a 29 public school academy, a nonpublic school, and any officers, board

- 1 members, or employees of those institutions are immune from civil
- 2 liability, both personally and professionally, for any damages
- 3 allegedly caused by, arising out of, or relating to the
