## **SENATE BILL NO. 480**

July 17, 2025, Introduced by Senators CHANG, CAVANAGH, GEISS, SANTANA and BAYER and referred to Committee on Housing and Human Services.

A bill to amend 1973 PA 116, entitled

"An act to provide for the protection of children through the licensing and regulation of child care organizations; to provide for the establishment of standards of care for child care organizations; to prescribe powers and duties of certain departments of this state and adoption facilitators; to provide penalties; and to repeal acts and parts of acts,"

by amending section 1 (MCL 722.111), as amended by 2024 PA 50.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) As used in this act:
- 2 (a) "Child care staff member" means an individual who is 16
- 3 years of age or older to whom 1 or more of the following apply:

- 1 (i) The individual is employed by a child care center, group
  2 child care home, or family child care home for compensation,
  3 including a contract employee or a self-employed individual.
- 4 (ii) An individual whose activities involve the unsupervised
   5 care or supervision of children for a child care center, group
   6 child care home, or family child care home.
  - (iii) An individual who has unsupervised access to children who are cared for or supervised by a child care center, group child care home, or family child care home.
- 10 (iv) An individual who acts in the role of a licensee designee
  11 or program director.
  - (a) "Child care center" means a facility, other than a private residence, receiving 1 or more children under 13 years of age for care for periods of less than 24 hours a day, where the parents or guardians are not immediately available to the child. Child care center includes a facility that provides care for not less than 2 consecutive weeks, regardless of the number of hours of care per day. The facility is generally described as a child care center, day care center, day nursery, nursery school, parent cooperative preschool, play group, before- or after-school program, or drop-in center. Child care center does not include any of the following:
  - (i) A Sunday school, a vacation bible school, or a religious instructional class that is conducted by a religious organization where children are attending for not more than 3 hours per day for an indefinite period or for not more than 8 hours per day for a period not to exceed 4 weeks during a 12-month period.
- 27 (ii) A facility operated by a religious organization where 28 children are in the religious organization's care for not more than 29 3 hours while individuals responsible for the children are

- 2 (iii) A program that is primarily supervised, school-age-child3 focused training in a specific subject, including, but not limited
  4 to, dancing, drama, music, or religion. This exclusion applies only
  5 to the time a child is involved in supervised, school-age-child6 focused training.
  - (iv) A program that is primarily an incident of group athletic or social activities for school-age children sponsored by or under the supervision of an organized club or hobby group, including, but not limited to, youth clubs, scouting, and school-age recreational or supplementary education programs. This exclusion applies only to the time the school-age child is engaged in the group athletic or social activities and if the school-age child can come and go at will.
- 15 (v) A program that primarily provides therapeutic services to 16 a child.
- 17 (b) "Child care organization" means a governmental or 18 nongovernmental organization having as its principal function 19 receiving minor children for care, maintenance, training, and 20 supervision, notwithstanding that educational instruction may be 21 given. Child care organization includes organizations commonly 22 described as child caring institutions, child placing agencies, 23 children's camps, children's campsites, children's therapeutic group homes, child care centers, day care centers, nursery schools, 24 25 parent cooperative preschools, foster homes, group homes, or child 26 care homes. Child care organization does not include a governmental 27 or nongovernmental organization that does either of the following:
- (i) Provides care exclusively to minors who have beenemancipated by court order under section 4(3) of 1968 PA 293, MCL

- 2 (ii) Provides care exclusively to individuals who are 18 years
- 3 of age or older and to minors who have been emancipated by court
- 4 order under section 4(3) of 1968 PA 293, MCL 722.4, at the same
- 5 location.
- 6 (c) "Child care staff member" means an individual who is 16 7 years of age or older to whom 1 or more of the following apply:
- 8 (i) The individual is employed by a child care center, group
- 9 child care home, or family child care home for compensation,
- 10 including a contract employee or a self-employed individual.
- 11 (ii) The individual's activities involve the unsupervised care
- 12 or supervision of children for a child care center, group child
- 13 care home, or family child care home.
- 14 (iii) The individual has unsupervised access to children who are
- 15 cared for or supervised by a child care center, group child care
- 16 home, or family child care home.
- 17 (iv) The individual acts in the role of a licensee designee or
- 18 program director.
- (d) (c)—"Child caring institution" means a child care facility
- 20 that is organized for the purpose of receiving minor children for
- 21 care, maintenance, and supervision, usually on a 24-hour basis, in
- 22 buildings maintained by the child caring institution for that
- 23 purpose, and operates throughout the year. An educational program
- 24 may be provided, but the educational program must not be the
- 25 primary purpose of the facility. Child caring institution includes
- 26 a maternity home for the care of unmarried mothers who are minors
- 27 and an agency group home, that is described as a small child caring
- 28 institution, owned, leased, or rented by a licensed agency
- 29 providing care for more than 4 but less than 13 minor children.

- 1 Child caring institution also includes an institution for
- 2 developmentally disabled or emotionally disturbed minor children.
- 3 Child caring institution does not include a hospital, nursing home,
- 4 or home for the aged licensed under article 17 of the public health
- 5 code, 1978 PA 368, MCL 333.20101 to 333.22260, a boarding school
- 6 licensed under section 1335 of the revised school code, 1976 PA
- 7 451, MCL 380.1335, a hospital or facility operated by the state or
- 8 licensed under the mental health code, 1974 PA 258, MCL 330.1001 to
- 9 330.2106, or an adult foster care family home or an adult foster
- 10 care small group home licensed under the adult foster care facility
- 11 licensing act, 1979 PA 218, MCL 400.701 to 400.737, in which a
- 12 child has been placed under section 5(6).
- (e) (d) "Child caring institution staff member" means an
- 14 individual who is 18 years of age or older to whom 1 or more of the
- 15 following apply:
- 16 (i) The individual is employed by a child caring institution
- 17 for compensation, including an adult who does not work directly
- 18 with children.
- 19 (ii) The individual is a contract employee or self-employed
- 20 individual with a child caring institution.
- 21 (iii) The individual is an intern or other individual who
- 22 provides specific services under the rules promulgated under this
- 23 act.
- (f) (e) "Child placing agency" means a governmental
- 25 organization or an agency organized under the nonprofit corporation
- 26 act, 1982 PA 162, MCL 450.2101 to 450.3192, for the purpose of
- 27 receiving children for placement in private family homes for foster
- 28 care or for adoption. The function of a child placing agency may
- 29 include investigating applicants for adoption and investigating and

- 1 certifying foster family homes and foster family group homes as
- 2 provided in this act. The function of a child placing agency may
- 3 also include supervising children who are at least 16 but less than
- 4 21 years of age and who are living in unlicensed residences as
- 5 provided in section 5(4).
- 6 (g) (f)—"Children's camp" means a residential, day, troop, or
- 7 travel camp that provides care and supervision and is conducted in
- 8 a natural environment for more than 4 children, apart from the
- 9 children's parents, relatives, or legal guardians, for 5 or more
- 10 days in a 14-day period.
- (h)  $\frac{(g)}{(g)}$  "Children's campsite" means the outdoor setting where
- 12 a children's residential or day camp is located.
- (i) (h)—"Children's therapeutic group home" means a child
- 14 caring institution receiving children who are diagnosed with a
- 15 developmental disability as defined in section 100a of the mental
- 16 health code, 1974 PA 258, MCL 330.1100a, or a serious emotional
- 17 disturbance as defined in section 100d of the mental health code,
- 18 1974 PA 258, MCL 330.1100d, and that meets all of the following
- 19 requirements:
- 20 (i) Provides care, maintenance, and supervision, usually on a
- 21 24-hour basis.
- 22 (ii) Has a capacity of not more than 6 children.
- 23 (iii) Complies with the rules for child caring institutions.
- 24 Emergency safety intervention in the form of physical management is
- 25 allowed but must comply with the mental health code, 1974 PA 258,
- 26 MCL 330.1001 to 330.2106, and associated administrative rules.
- 27 (iv) Is not a private home.
- (v) Is not located on a campus with other licensed facilities.
- (i) "Child care center" means a facility, other than a private

residence, receiving 1 or more children under 13 years of age for 1 2 care for periods of less than 24 hours a day, where the parents or guardians are not immediately available to the child. Child care 3 4 center includes a facility that provides care for not less than 2 consecutive weeks, regardless of the number of hours of care per 5 6 day. The facility is generally described as a child care center, 7 day care center, day nursery, nursery school, parent cooperative 8 preschool, play group, before- or after-school program, or drop-in 9 center. Child care center does not include any of the following: 10 (i) A Sunday school, a vacation bible school, or a religious instructional class that is conducted by a religious organization 11 12 where children are attending for not more than 3 hours per day for 13 an indefinite period or for not more than 8 hours per day for a 14 period not to exceed 4 weeks during a 12-month period. 15 (ii) A facility operated by a religious organization where children are in the religious organization's care for not more than 16 3 hours while individuals responsible for the children are 17 18 attending religious services.

(iii) A program that is primarily supervised, school-age-child-focused training in a specific subject, including, but not limited to, dancing, drama, music, or religion. This exclusion applies only to the time a child is involved in supervised, school-age-child-focused training.

(iv) A program that is primarily an incident of group athletic or social activities for school-age children sponsored by or under the supervision of an organized club or hobby group, including, but not limited to, youth clubs, scouting, and school-age recreational or supplementary education programs. This exclusion applies only to the time the school-age child is engaged in the group athletic or

  2 will.
- 3 (ν) A program that primarily provides therapeutic services to
  4 a child.
- (j) "Conviction" means a final conviction, the payment of a fine, a plea of guilty or nolo contendere if accepted by the court, a finding of guilt for a criminal law violation or a juvenile adjudication or disposition by the juvenile division of probate court or family division of circuit court for a violation that if committed by an adult would be a crime, or a conviction in a tribal court or a military court.
  - (k) "Criminal history check" means a fingerprint-based criminal history record information background check through the department of state police and the Federal Bureau of Investigation.
- 15 (l) "Criminal history record information" means that term as defined in section 1a of 1925 PA 289, MCL 28.241a.
  - (m) "Department" means the department of lifelong education, advancement, and potential, the department of health and human services, and the department of licensing and regulatory affairs or a successor agency or department responsible for licensure under this act. The department of licensing and regulatory affairs lifelong education, advancement, and potential is responsible for licensing and regulatory matters for child care centers, group child care homes, family child care homes, children's camps, and children's campsites. The department of health and human services is responsible for licensing and regulatory matters for child caring institutions, child placing agencies, children's therapeutic group homes, foster family homes, and foster family group homes.
    - (n) "Drinking fountain" means a plumbing fixture that is

- 1 connected to the potable water distribution system and drainage
- 2 system that allows the user to obtain a drink directly from a
- 3 stream of flowing water without the use of any accessory.
- 4 (o) "Eliqible" means that the individual obtained the checks
- 5 and clearances described in sections 5n and 5q and is considered
- 6 appropriate to obtain a license, to be a member of the household of
- 7 a group child care home or family child care home, or to be a child
- 8 care staff member.
- 9 (p) "Faucet" means a valve end of a water pipe by which water
- 10 is drawn from or held within the pipe.
- 11 (q) "Filtered bottle-filling station" or "station" means an
- 12 apparatus that meets all of the following requirements:
- 13 (i) Is connected to customer site piping.
- 14 (ii) Filters water and is certified to meet NSF/ANSI standard
- 15 53 for lead reduction and NSF/ANSI standard 42 for particulate
- 16 removal.
- 17 (iii) The flow rate through the station is paired to the
- 18 specified flow rate of the filter cartridge.
- 19 (iv) Has a light or other device to indicate filter cartridge
- 20 replacement status.
- 21 (v) Is designed to fill drinking bottles or other containers
- 22 for personal water consumption.
- 23 (vi) Includes a drinking fountain.
- 24 (r) "Filtered faucet" means a faucet that at the point of use
- 25 includes a filter that is certified to meet NSF/ANSI standard 53
- 26 for lead reduction and NSF/ANSI standard 42 for particulate
- 27 removal.
- 28 (s) "Filtered pitcher" means a container used for holding and
- 29 pouring liquids that at the point of use includes a filter that is

- 1 certified to meet NSF/ANSI standard 53 for lead reduction and
  2 NSF/ANSI standard 42 for particulate removal.
- 3 (t) "Guardian" means that term as defined under section 1104 4 of the estates and protected individuals code, 1998 PA 386, MCL 5 700.1104.
- 6 (u) "Increased capacity" means 1 additional child added to the
  7 total number of minor children received for care and supervision in
  8 a family child care home or 2 additional children added to the
  9 total number of minor children received for care and supervision in
  10 a group child care home.
  - (v) (t) "Ineligible" means that the individual obtained the checks and clearances as described in sections 5n and 5q and is not considered appropriate to obtain a license, to be a member of the household of a group child care home or family child care home, or to be a child care staff member due to violation of section 5n, 5q, or 5r.
  - (u) "Increased capacity" means 1 additional child added to the total number of minor children received for care and supervision in a family child care home or 2 additional children added to the total number of minor children received for care and supervision in a group child care home.
    - (v) "Private home" means a private residence in which the licensee permanently resides, which residency is not contingent upon caring for children or employment by a child placing agency. Private home includes a full-time foster family home, a full-time foster family group home, a group child care home, or a family child care home, as follows:
- 28 (i) "Foster family home" means the private home of an
   29 individual who is licensed to provide 24-hour care for 1 but not

The licensed individual providing care is required to comply with the reasonable and prudent parenting standard as 11 12 defined in section 1 of chapter XIIA of the probate code of 1939, 1939 PA 288, MCL 712A.1. 13 14 (iii) "Family child care home" means a private home in which 1 but fewer than 7 minor children are received for care and 15 supervision for compensation for periods of less than 24 hours a 16 17 day, unattended by a parent or legal guardian, except children 18 related to an adult member of the household. Family child care home 19 includes a home in which care is given to an unrelated minor child 20 for more than 4 weeks during a calendar year. A family child care 21 home does not include an individual providing babysitting services 22 for another individual. As used in this subparagraph, "providing babysitting services" means caring for a child on behalf of the 23 24 child's parent or quardian if the annual compensation for providing 25 those services does not equal or exceed \$600.00 or an amount that 26 would according to the internal revenue code of 1986 obligate the 27 child's parent or quardian to provide a form 1099-MISC to the 28 individual for compensation paid during the calendar year for those services. Family child care home includes a private home with 29

- 1 increased capacity.
- 2 (iv) "Group child care home" means a private home in which more
- 3 than 6 but not more than 12 minor children are given care and
- 4 supervision for periods of less than 24 hours a day unattended by a
- 5 parent or legal guardian, except children related to an adult
- 6 member of the household. Group child care home includes a home in
- 7 which care is given to an unrelated minor child for more than 4
- 8 weeks during a calendar year. Group child care home includes a
- 9 private home with increased capacity.
- 10 (w) "Legal custodian" means an individual who is at least 18
- 11 years of age in whose care a minor child remains or is placed after
- 12 a court makes a finding under section 13a(5) of chapter XIIA of the
- 13 probate code of 1939, 1939 PA 288, MCL 712A.13a.
- 14 (x) "Legal entity" means a sole proprietorship, partnership,
- 15 corporation, limited liability company, or any other entity.
- 16 (y) "Licensee" means a person, legal entity organized under a
- 17 law of this state, state or local government, or trust that has
- 18 been issued a license under this act to operate a child care
- 19 organization.
- 20 (z) "Licensee designee" means the individual designated in
- 21 writing by the board of directors of the corporation or by the
- 22 owner or person with legal authority to act on behalf of the
- 23 company or organization on licensing matters. The individual must
- 24 agree in writing to be designated as the licensee designee. All
- 25 license applications must be signed by the licensee in the case of
- 26 the individual or by a member of the corporation, company, or
- 27 organization.
- 28 (aa) (z)—"Listed offense" means that term as defined in
- 29 section 2 of the sex offenders registration act, 1994 PA 295, MCL

- 28 (gg) (dd)—"Psychiatric residential treatment facility" or
- 29 "PRTF" means a facility other than a hospital that provides

- 1 psychiatric services, as described in 42 CFR 441.150 to 441.184, in
- 2 an inpatient setting to individuals under the age of 21. Emergency
- 3 safety intervention in the form of physical management is allowed
- 4 but must comply with the mental health code, 1974 PA 258, MCL

- 27 primarily for detaining minor children who are determined to be
